## **Trojan Horses and Handmaidens**

Back in the day, my grandmother inherited farmland from her grandfather. Then Uncle Sam decided that he needed the land for a military base. He paid her a fair price of the principle of eminent domain only in terms of real estate. In fact, a government might not just take your property. When we do not abide by the law, the State often finds that it has a compelling interest to take your money, your liberty, or even your life.

The Handmaiden's Tale is a fictional story of a dystopian state that asserts eminent domain, if you will, over the wombs of fertile women. Advocates of Proposal 5 think their proposed amendment to the Vermont constitution will prevent that from ever happening. It will not.

Most attention has been focused on the first part of the proposal. We need to consider the Trojan horse included in the proposal, "unless justified by a compelling State interest achieved by the least restrictive means." There is no indication of what might be considered a "compelling State interest." Vermonters are being asked to hardwire into the constitution the potential of eminent domain over wombs for whatever compelling interests the State may assert at any time in the future.

This means that a simple majority in the state legislature, either with a governor's signature or the lack of a sustainable veto, can declare a "compelling State interest" and and took the land. We usually think assert eminent domain, so to speak, est to limit families to one child. over reproductive autonomy. It would be challenged in court, to be sure, but there would be no need to repeal the proposed Article 22 or to add a new amendment to the state constitution. This is the Trojan horse. Proposal 5 is a political gesture with no real guarantees. If it passes in November, people that vote for it will think they have a victory but it contains the seeds of defeat.



Advocates of Proposal 5 may lie awake at night worrying about Vermont becoming the next Texas or Mississippi. Not likely, but Vermont was solidly Republican for over a century before quickly becoming one of the most liberal states in the country. A major cultural shift has happened here before and could happen again. The current political drift makes an op-

posite scenario more likely.

In 1979, the Communist Chinese government embraced the idea that there was a compelling state inter-They even put it in their constitution. Instead of the State requiring birth, it *required* abortion. This is not fiction. Check out the documentary, "One Child Nation", if vou want to see a real dystopia.

The 2020 census shows 26 US cities with a greater population than the State of Vermont, yet our politicians periodically make gestures toward saving the planet from humanity. They may congratulate themselves on their virtue but the gestures have only a tiny intended impact. We are more in danger of becoming a Progressive dystopia of limited family size than of anything the Left may fear.

Is Proposal 5 rooted in a strong libertarian philosophy? For example, "The government that governs least governs best?" Or is there a "will to power" that would make Nietzche proud? It appears that those that drafted this proposal were loath to leave out the State's interest. In doing so, they have created something that no Vermonter should want, Left, Right, or Center.

# **5 REASONS TO OPPOSE PROP 5/ARTICLE 22**



1. UNSTOPPABLE LATE-TERM, ANYTHING GOES ABORTIONS Abortions that terminate fully-developed babies able to live outside the womb will be constitutionally protected. Babies could be aborted days before their birthdays, for any reason, or no reason at all.

#### 2. CONSCIENCE PROTECTIONS PROHIBITED

Article 22 will not only mean no restriction whatsoever of late-term abortions, it would force doctors and nurses to assist in procedures like late-term abortions and sterilizations of minor children -- even **against their medical judgment** -- or be fired, without recourse.



**4. TAXPAYER FUNDING** With a "constitutional right" comes government funding. Taxpayers will be required to pay for procedures related to "reproductive choice" -- such as late-term abortion, abortions as birth control, and even sterilization -- regardless of fiscal circumstances or what the public wants.



3. PARENTAL INVOLVEMENT LIMITED

Parents would be prevented from being notified about their child's "reproductive" choices of sterilization or abortion, regardless of age or circumstance.





#### 5. UNFORESEEN CONSEQUENCES

Proposal 5 never mentions "women," "abortion," "pregnancy," or "choice." During a public hearing, supporters of Article 22 were asked: "What would happen if a man asserted a right to reproductive autonomy under Proposal 5 and tried to stop an abortion?" They said, "when rights are in conflict, we go to court." The lawsuits will be endless, and no one can pretend to know how future courts will rule on such vague language.

# **5 MYTHS ABOUT PROPOSAL 5/ARTICLE 22**



### 1. WE NEED TO PASS ARTICLE 22 TO KEEP ABORTION LEGAL.

**FALSE.** If Article 22 does NOT pass in November, abortion will still be legal in Vermont -- Vermont's laws will not change. But passing Article 22 means the people, hospitals, and the legislature cannot set common sense policies limiting late-term abortion.

#### 2. I'M PRO-CHOICE SO I SHOULD SUPPORT ARTICLE 22. FALSE. A

majority of people who consider themselves pro-choice still believe that abortion should be regulated and limited in the latter stages of pregnancy -- especially after the unborn child is developed enough to be **viable outside the womb**. Article 22's proposition that abortion at any stage of pregnancy cannot and should not be legally limited at all is radically outside the mainstream of most Vermonters' values.





### 3. ARTICLE 22 JUST CODIFIES ROE V. WADE, FALSE.

Roe v. Wade created a legal framework based on the "trimesters" of pregnancy, guaranteeing a woman's unlimited right to choose an abortion only in the first trimester, but allowing common sense regulation of late term abortions, such as prohibitions on

partial-birth abortions. But **Article 22 goes far beyond Roe** by eliminating and preventing any limitations of late-term abortion whatsoever. It goes too far.

### 4. ARTICLE 22 PROTECTS US FROM A FEDERAL ABORTION BAN.

**FALSE**. The "Supremacy Clause" in the US Constitution means Article 22 would not prevent any future federal laws affecting abortion nationwide from overriding Article 22. But Article 22 would prevent Vermont voters and our legislators from regulating or limiting late-term abortion at the state level as we see fit by enshrining unlimited late-term abortion right up to birth in the Vermont Constitution.





#### 5. LATE-TERM ABORTIONS DON'T HAPPEN IN VERMONT.

**FALSE.** Right now, many hospitals in Vermont have corporate policies that are highly restrictive regarding late-term abortions. However, if Article 22 passes, there will be NO LAWS or policies, and none allowable, limiting or regulating abortion at any time during pregnancy up to birth. Laws designed to protect women's health, regulate who can

perform abortions and under what conditions, or to protect unborn children who are viable outside the womb from late-term abortion would all be unconstitutional.
