Food Vendor Rules and Regulations

- Schedule** Vendors must have food preparation area set up by 6:00 PM on Friday, October 11, 2024. Vendors must be ready to serve by 8:00 AM on Saturday, October 12, 2024. **You may not take down any part of your booth before 4:00 PM on Saturday. NO EXCEPTIONS**
- Check-in** **Friday, October 11, 9:30 AM - 6:00 PM and Saturday, October 12, 5:00 AM - 6:30 AM**
Passes for VENDOR PARKING are available **ONLY** at check-in.
- Food** Vendors may sell **ONLY** the products noted in the contract and approved by festival committee. Vendors must display a sign listing food items and prices.. All vendors must have hand sanitizer available to the public.
- Vendors** Vendors and employees must be properly attired. Alcoholic beverages are not permitted. Vendor pets are not permitted at the Festival.
- Weather** The 1890s Festival is **RAIN-OR-SHINE**. Booth fees are not refunded because of weather.
- Power** Generators must be WHISPER QUIET and equipped with sound barriers. **NO LOUD GENERATORS ARE ALLOWED.**
No cords or hoses are allowed on the street. NO EXCEPTIONS.
- Fire** All vendors are required to have a 5-pound extinguisher with Class A or B rating at each booth. Vendors who use fryers or similarly flammable equipment are required to have a Type K fire extinguisher. Coals must be removed from Festival grounds.
- Appearance and Decorum** Booths must be clean and tidy and fit in with the family-friendly nature of the 1890s Festival. Vendors are expected to be friendly and helpful to guests and comply with Festival Committee requests.
- Trash** Vendors must have two trash cans with plastic bag liners at each booth. Trash will be picked up at the end of the day. Please place your bags at the street for pickup. You are responsible for keeping your area clean.
- Security** Vendors are responsible for the safety and security of their money, equipment, inventory, and all personal property.
- Insurance** Vendors are required to provide documentation of \$1,000,000.00 of recovery liability coverage with Friends of McIntosh named as additional insured. You may not be in the show without insurance.

Vendors who do not comply with 1890s Festival rules and regulations may be asked to close their booth immediately and will not be considered for future festivals.
