Items must be at least 50% hand crafted.
No commercial booths are allowed.
- Each Exhibitor will be assigned a 12'wide x 10'deep space.** Only one exhibitor per space. One tent per site.
- This is an outdoor show; there is no completely level ground.** To be fair to all exhibitors, booth spaces will be assigned randomly. Set-up, take-down, and designated parking will be strictly adhered to. Arrival late or leaving early will not be tolerated. Any exhibitor who leaves the area early will not be allowed to exhibit in the future.
- NO VENDOR PETS IN THE EXHIBITING AREA**
- Exhibitors are responsible for care and protection of their exhibit area.** The Friends of McIntosh will not assume responsibility. Exhibitors are responsible for the overall appearance of their booths which should reflect the professionalism of the promotion. All refuse must be removed from the premises upon leaving. Exhibitors are expected to return their area to its original conditions.
- Exhibitors may check in from 9:30 am until 6:00 pm on Friday (10/11/24) and from 5:00 am until 6:30 am on Saturday (10/12/24).** Exhibitors will be given a parking pass (for one vehicle only) at check-in point which may be used to park in the area reserved for Festival Exhibitors. Exhibitors are requested to limit themselves to one vehicle and **must** have their vehicles removed from the exhibit area by 7:00 am. Any vehicles parked in an undesignated area will be towed away at the owner's expense, and that exhibitor will not be allowed to participate in future shows.
- All exhibitors are responsible for collecting and mailing state sales tax (7%) to the Florida Revenue Commission.
- In the event of emergencies, we will refund your registration fee if we are able to fill your space.**
There are no refunds due to weather.
