**NO COMMERCIAL BOOTHS ARE ALLOWED.**

**3. The Festival Committee reserves the right to withhold entry on any work.** Any application deemed to be unsuitable will be refused and the Registration Fee will be refunded. **Participating in previous festivals does not assure a place in this or future festivals.**

**4. The Festival Committee will endeavor to have adequate representation** in each of the following categories:  
Arts and Photography • Dried Flowers • Pottery • Jewelry  
Basketry • Clothing • Woodworking • Crafts • Weaving  
Antiques • Plants • Homemade Foods • Stained Glass  
**ITEMS MUST BE AT LEAST 50% HAND CRAFTED.**

I understand that refunds are not assured if the Festival is cancelled.

\*Your \$10.00 application fee will be deposited upon receipt. This does not assure your acceptance into the show.

- 6. Each vendor will be assigned a 12’ wide x 10’ deep space.**  
Only one vendor per space. One tent per site.
- 7. This is an outdoor event; there is no completely level ground.** To be fair to all vendors, booth spaces will be assigned randomly. Set-up, take-down, and designated parking will be strictly adhered to. Arriving late or leaving early will not be tolerated. Any vendor who leaves the area early will not be allowed to participate in the future.
- 8. Vendors are responsible for care and protection of their exhibit area.** The Friends of McIntosh will not assume responsibility. Vendors are responsible for the overall appearance of their booths which should reflect the professionalism of the event. All refuse must be removed from the premises upon leaving. Vendors are expected to return their area to its original conditions.  
**NO VENDOR PETS IN THE EXHIBITING AREA**
- 9. Vendors are responsible for maintaining a civil and polite atmosphere that reflects the professionalism of the Festival.** That civility will extend to customers/festival goers; fellow vendors; all McIntosh 1890s Festival social media; and festival staff, maintenance, and security.
- 10. Vendors may check in from 9:30 am until 6:00 pm on Friday (11/7/25) and from 5:00 am until 6:30 am on Saturday (11/8/25).** Vendors will be given a parking pass (for one vehicle only) at check-in point which may be used to park in the area reserved for Festival Vendors. Vendors are requested to limit themselves to one vehicle and **must** have their vehicles removed from the exhibit area by 7:00 am. Any vehicles parked in an undesignated area will be towed away at the owner’s expense, and that vendor will not be allowed to participate in future shows.
- 11. All vendors are responsible for collecting and mailing state sales tax (7.5%) to the Florida Revenue Commission.**
- 12. The McIntosh 1890s Festival is a *Rain or Shine* event.**  
**There are no refunds due to weather.**

**The Festival may be cancelled by one or more of the following *beyond the control of the Friends of McIntosh:***

- Order by official state or local entity such as Governor, Sheriff, Health Department, Department of Transportation, or Town of McIntosh.
- Lack of necessary/required services such as vendor parking, electricity, water, toilets, and insurance.
