#### <u>INSTRUCTIONS FOR LINING UP IN PARADE</u>

The parade will line up on Kings Highway between Bennett's Pasture Road and Sleep Hole road at 9:00 am. It is **MANDATORY** that you come down Sleepy Hole Road and turn onto Kings Highway to line up in this parade. If you have turned onto Sleepy Hole Road from Bennett's Pasture Road, you will be making a left onto Kings Highway. If you have turned onto Sleepy Hole Road from Nansemond Parkway, you will be making a right onto Kings Highway. Once you have turned on to Kings Highway, please travel very slowly until you see the participants. Please leave approximately 50 feet between yourself and the participant in front of you. We would sincerely appreciate your application no later than Monday, October 10, 2022; however, exceptions can be made. The goal is to have all walking groups in the front of the parade, followed by all motorized vehicles, which will be lined up in the order you arrive. If you have a specific group you would like to follow, please come to the line up together. The final lineup will be given to the commentator at 9:40 a.m. Saturday morning. If you arrive later than 9:40, you will be placed in the back of the line for safety reasons. Safety is of the utmost importance when lining up this parade.
