
## WHAT BLOCKCHAIN?

\$FJCC was built on the Ethereum network as it is the most recognized blockchain. This was chosen because of it's security and it is already well-established. We also made this choice because it was the best way to ensure we stay decentralized.

Our founder wanted to ensure that this project was free to change and evolve with zero outside regulations impacting it. All \$FJCC holders are able to hold their own tokens in a wallet and collect payments, all while remaining independent of moderating forces.



# HOW IT WORKS- THE BASICS



### TOKENOMICS OF FJCC

\$FJCC is a decentralized finance (DeFi) token that operated on the Ethereum blockchain (ERC-20).

\$FJCC will launch their ICO on May 1st 2024 priced at .0000029 ETH.

23% of total supply will be available to early investors through a three level ICO. Level 1 investors will have input in the programs offered, access airdrops prior to listing on exchange, and various other rewards. We consider every ICO token holder a partner and you will be treated as such.

23% of total supply will be transferred to the community wallet to be used towards FJCC programs after completion of the ICO.

## TOKEN / LOCK

At ICO 32% of the token supply is locked and it will be used for Exchange Listing, and reserve for FJCC programs. The wallet used for FJCC programs will be made public post ICO so all \$FJCC holders can ensure these tokens are being used for their intended use. These tokens will only be locked for 3 months while we determine which exchange to release \$FJCC on. \$FJCC purchased at ICO will only be locked for 5 days.



ICO \$FJCC holders will have many rewards including airdrops prior to Exchange listing, Access to events to vote on the programs we will be offering, and other rewards to be determined. We also have built a burn feature which we are prepared to use prior to listing on the exchange if it is needed to increase \$FJCC holder value.
