## Nancy Breth "The Practice Triangle"

#### The Practice Triangle

Parent, teacher, student: what role does each one have in practicing the piano? How should one work with and relate to the other, from the initial interview through the senior recital? How can teachers motivate parents to motivate their children? How can parents help, and not help? Who should attend lessons and why? Questions to ask parents about children; questions to ask children about parents. What to do when the triangle shatters.

#### Biography

Nancy O'Neill Breth teaches piano and chamber music to students of all ages in the Washington, DC metro area. Nancy collaborates with teachers at home and throughout the country. She's headlined a number of state MTA conferences, and 2020 marked her filh appearance as a presenter at MTNA's national conference. Her latest projects for teachers and students are Effective Practicing, a collection of short You Tube videos for pianists, and a clickable list of Modern Piano Music.

Breth piano and chamber music students are frequent laureates in state, national and international competions. Several appeared on National Public Radio's "From the Top"; three duet teams won MTNA's national Piano Duet competition. Her students have been privileged to attend Aspen Music Festival, the Tanglewood Institute, Indiana University Piano Academy, Greenwood Chamber Music Camp, and the International Institute for Young Musicians; some earned music degrees from the conservatories of Juilliard, New England and Eastman and the universities of Indiana, Miami, and Maryland. Several former students hold piano professorships in university schools of music.

Nancy worked as a collaborative pianist and arts presenter in the United States, Latin America and Asia. The Washington Post praised her "superb musicianship", calling her Music Connection concert series "brilliant" and "imaginative". The Mexico City News wrote that Breth's Camerata de Mexico "offers the best chamber music in Mexico." In New York City Nancy was producer/director of a children's opera by Michael Colgrass, and built an acclaimed chamber music program for the children of Roosevelt Island. #### Tidewater Music Teachers Forum

Nancy taught piano, chamber music and pedagogy at Washington DC's Levine School of Music for many years. Under her leadership as chair of Levine's Chamber Music Department, the number of adults and children studying chamber music at the school grew from around 40 to almost 400.

Nancy has written for American Music Teacher, Keyboard Companion and Clavier Magazine. Her publications have sold over 50,000 copies worldwide. They include The Piano Student's Guide to Effective Practicing, the Parents' Guide to Effective Practicing, Practicing the Piano, and a set of elementary piano trios from John Gay's The Beggars Opera, all published by Hal Leonard Corporation. She is active in three Music Teachers Associations, and enjoys frequent judging jobs at home and throughout the country.

Dear Fellow Music Teachers,

# The VMTA Theory Test 2022

### Teachers,

The pandemic has caused the following changes for this year.

- For this coming 2022 VMTA Theory Test, all teachers will administer the Theory Test to their students in their own private studios. See the Deadline Dates below.
- Scores will be submitted by the deadline to Marilyn Forman, TMTF Theory Chairman.
- The Theory Test will not be required for the Eastern District Auditions.

However, the Theory Test will be offered this year, and the scores will be recorded.

#### Listed below are the deadline dates for the Theory Test.

Registration Deadline:

February 1, 2022 ners: March 1, 2022

VMTA Test mailed to teachers: March 1, 2022
Deadline to submit scores: April 20, 2022



Students can take only one test per year. The fee is **\$14.00** for one test. **Mail the Registration Form and include one check reflecting the sum of the students entered and payable to TMTF**. Do not have students mail their registration to the Theory Chairman. <u>Only the teachers should mail the</u> <u>Registration form and the one check totaling the registration</u> <u>sum amount of the students entered to Marilyn Forman, TMTF</u> <u>Theory Chair.</u>

#### **Reminders:**

•Students may enter the program at any level or skip levels at the discretion of their teacher.

•Students who previously failed a test can go to the next level provided the private teacher tests and approves the student to proceed.

•The knowledge required for the Theory Test is cumulative and may include questions based on materials required from previous levels. There are no retakes for failures in the same year.

**UPDATE ON 2022 MTNA NATIONAL CONFERENCE IN MINNEAPOLIS** 

On Monday, January 17, the MTNA Board of Directors made the very difficult decision that the inperson 2022 MTNA National Conference, scheduled to be held in Minneapolis March 26–30, will not take place as planned. Instead, MTNA will pivot to a virtual-only conference to be held on the same dates.

The decision to move ahead with the in-person conference in Minneapolis was made many months ago when confidence was high that the pandemic would abate and our members would be able to attend without jeopardizing their health and safety. Instead, the Omicron variant has increased infection rates to record levels. It is much more contagious than the Delta variant, and it even bypasses the antibodies produced by the vaccines and infects those who are vaccinated.

Unfortunately, the Omicron variant is currently raging out of control in the city of Minneapolis. On January 12, the mayor issued an emergency regulation, which takes effect on January 26 and continues indefinitely, that identifies indoor dining as a significant driver of the COVID-19 pandemic. The order establishes highly restrictive rules on places that sell or serve food and drink for on-site consumption, and the negative implications for access to and consumption of food by our attendees in and around the hotel and convention center are profound.

Given the uncertainty of the spread and impact of the virus over the next few weeks, along with the almost certain possibility of additional, unforeseen virus-related restrictions in Minneapolis, it became clear that MTNA had to take action to ensure the health, safety and well-being of MTNA members, presenters, artists, exhibitors and competitors who attend the in-person conference. Out of an abundance of caution, the Board made the wise decision to pivot to a virtual-only conference.

We know that many of you will have questions, and we are working to have more information available soon, which will be shared on the MTNA website, social media channels and email. Those who have already registered for the in-person conference will receive communication in the coming days on converting their registration to the virtual conference and receiving a refund on the difference, or receiving a full refund. Those who have already registered for the virtual conference do not need to do anything.

We all look forward to the time when an in-person conference may be held safely and responsibly. In the meantime, the MTNA Virtual Conference, to be held March 26–30, will provide the valuable and treasured professional development and networking event you have come to expect from MTNA.


