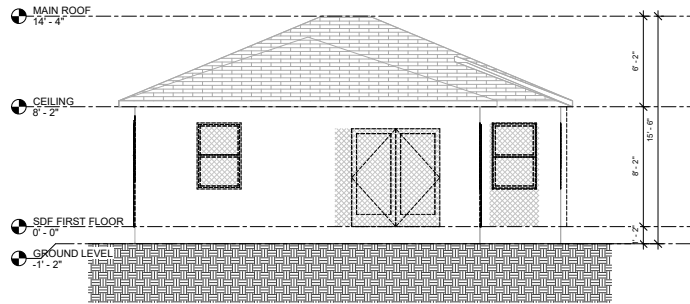

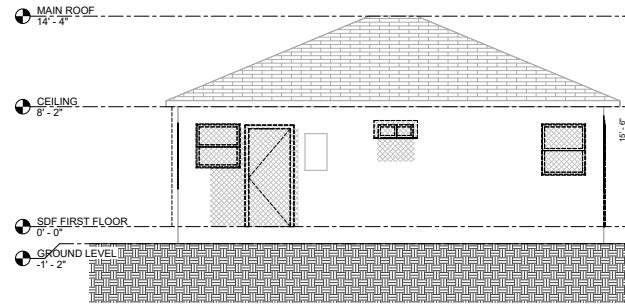

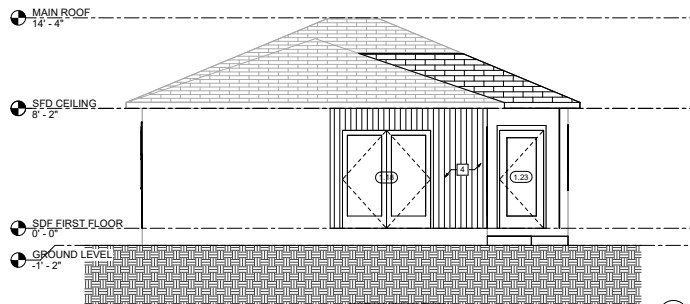
NORTH ELEVATION

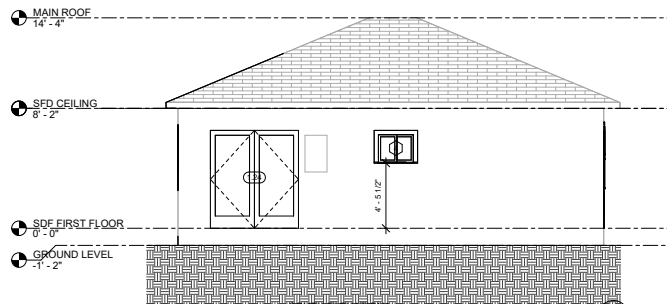
SOUTH ELEVATION
