

Exhibit Rules and Regulations

Lake of the Woods Artists and Fareways implements the following rules and regulations for its Fareways exhibits.

We ask that Artists and Art makers read and adhere to the rules and regulations, as Fareways reserves the right to refuse submission to any Exhibit and will not accept artworks that do not comply with the stated rules and regulations.

Observing the following points ensures that your artwork will be exhibited in the best possible way.

We appreciate your support.

Fees

- 1) There are **no entry fees** for the exhibit but the artist must be a member of Lake of the Woods Artists who has paid dues the yearly club dues (Active Member)
- 2) The artist is required to provide a mandatory 15% commission to the Lake of the Woods Artists (treasurer) for all artwork sold.

Sales

- 1) Lake of the Woods Artists will not handle sales transactions for this exhibit. All sales will take place between the artists and the buyer.
- 2) The sales transaction must take place outside of the Fareways building as per Fareways request.
- 3) QR codes are posted around Fareways as a link to a page with prices and information about all pieces on display.
- 4) When a work of art is sold the artists has the option to replace the piece with another similarly sized work within 48 hours of removal
- 5) If the artists chooses not to replace sold work the space will be offered to another Lake of the Woods Artists member.

Size

Maximum size for all artwork, is as follows:

Two-dimensional work, 2D, measurements can be no larger than 36" in width and 36" in height.

Two Dimensional Art and Framing

All works on paper, including photographs, must be framed. Glass and Plexiglas must be clean inside and out, unscratched and intact.

Works on canvas should be framed or have gallery-wrapped, finished edges with no staples visible.

A hanging wire must be firmly attached to the back with screw-eyes or D-rings, and the wire not exceeding the top of the frame.

Artwork must be completely dry at time of submission.

Paperwork for submission

When dropping off your artwork please include the following required documents:

- 1) Your completed Artists Exhibit Inventory sheet
- 2) Your completed Fillable price tags

Originality and Prints

All entries must be original works and not previously shown in a Fareways exhibit.

3D Work

All 3D work must be of an appropriate size for table-top display. The artist must provide all display equipment such as jewelry forms, easels etc. The 3D show is for 2 hours during the artist reception only. Artists must set up their work just prior to the beginning of the reception and break it down and remove it at the conclusion of the reception.

Please be mindful of copyright infringements.

Copies and reproductions of original works of art, whether embellished or not, are not eligible for submission to exhibits. However, fine art prints such as photographs, lithographs, woodcuts, engravings, etchings, screen prints and digital works *are acceptable* as long as they are labeled as such and numbered as an edition.

Withdrawal

Work accepted for an exhibition may not be substituted, nor will any artwork be withdrawn during any exhibition, in any circumstance. When accepting the invitation to be in the exhibit they are **committing that work to the exhibit for its entire duration**.

Review and Inclusion in Exhibition

All Entries will be reviewed at the time of submission to ensure adherence to the artwork condition rules and regulations of the exhibit.

Inclusion / Exclusion in the exhibit is at the sole discretion of Fareways. Art will be reviewed for adherence to rules and regulations and Fareways/Lake of the Woods Artists reserves the right to refuse submission based on the terms stated within.

The number of pieces included in the exhibit will depend upon the space available, the size of the artworks selected and the order in which they were received.

Fareways reserves the right to turn away any submissions that it deems inappropriate for our younger viewers or offensive in subject matter.

Works with overtly pornographic, discriminatory or violent messages may be barred from submission.

By submitting work for entry the artist agrees to allow representations of work to be shown and reproduced for publicity purposes.

Statement of Responsibility

All entries are left at the owner's risk—Neither Lake of the Woods Artists nor Fareways is responsible for any loss or damage to submitted artwork by any means whatsoever. Lake of the Woods Artists volunteers will take all necessary precautions in handling artwork.

Artwork Pickup

Artwork is to be picked up on the specified days listed on the Call for Art. If you cannot pick up your work please arrange for someone else to pick it up and sign it out for you. Please let us know who will be picking up your work.

Fareways will not store any work.

Miscellaneous

Once an accepted piece of artwork is installed in a show, no requests for moving any art pieces, or to change the location of any art pieces, will be considered or accepted. Placement and position of art in any Exhibit is at the discretion of Lake of the Woods Artists. If there are requests and directions, in regards to any piece of art entered to an Exhibition, please supply and furnish those requests upon the art submission and delivery.

Should an exhibitor move away from the area and need to remove their art for this purpose their space will be made available to other artists.
