Hospitality Policy Clarification

Motion: To approve the Board-approved replacement of the current Convention Policy section titled “Hotels & Hospitality” with the clean replacement section titled “Hospitality,” as a time-frame policy motion.

Intent

To correct previously approved Convention Policy language that unintentionally assigns hotel negotiation, hotel liaison, space-planning, and contract-related responsibilities to the Hospitality Subcommittee, although those responsibilities are reserved to the GNYRSO Board of Directors, the Convention Chair/Steering Committee, or other appropriate convention service positions.

This correction renames the section from “Hotels & Hospitality” to “Hospitality” and restores the subcommittee to its intended purpose: greeting convention attendees, staffing and supervising the Hospitality Room, coordinating refreshments and fellowship activities, supporting appropriate room materials, and assisting with marathon/fellowship space as directed.

This motion is submitted as a time-frame policy motion so the newly elected Convention Committee can begin its work with clear duties, proper lines of accountability, and no confusion about who has authority to interact with the hotel or bind the GNYRSO.

Clean Replacement Language Submitted for Approval

The clean replacement language below is the language being submitted for approval. Any markup/redline version is included only for reference and transparency.

Section 8. Hospitality: The role of the Hospitality Committee is to greet convention attendees, staff and supervise the Hospitality Room, coordinate refreshments and fellowship activities, support appropriate room materials and assist with fellowship space as needed.

The Hospitality Chairperson serves as the Convention Host, organizing a committee that will greet all guests, maintain bulletin boards and announcements, maintain a predetermined coffee schedule (optional), replenishes snacks as needed (optional), and assigns shifts for the Hospitality Room staffing. The Hospitality Room will only be closed during the main meetings.

The duties of the Hospitality Committee Officers are to:

- Recruit members to this subcommittee.
- Hold regular subcommittee meetings.
- Attend all convention committee meetings
- Submit a function specific written report at all convention committee meetings.
- Maintain accurate records of all their activities as well as all correspondence. Financial reports, including need, expenditures, and receipts are included with each subcommittee report.
- Present a budget to the Convention treasurer of all estimated subcommittee costs.

Items to be provided in the hospitality room shall be:

- Lost and Found Bulletin
- Local Meeting Schedule
- NA Literature
- Map of the Area and any local restaurants
- Information on transportation to and from the airport
- Subway and bus maps for local travel; and

GNYRCNA Convention Policy Clarification

- Activities such as backgammon, cards, chess, checkers, and other board games

The Hospitality subcommittee Chairperson shall form 2 teams (Hospitality Room Monitors Decorations), with a team leader for each appointed therein, to perform the following functions:

Hospitality Room Monitors:

- Have poster boards with the Do's and Don'ts displayed in the hospitality room or rooms; and
- Monitor the Hospitality Room for inappropriate behavior such as gambling, sex, storage of personal effects, smoking, fighting, rough housing, unsupervised children, etc.

Decorations: responsible for designing and producing centerpieces for Banquet and Breakfast tables, as well as any additional decorations required by GNYRCNA.

Prepare and present a final post-convention report at the final convention committee meeting with as much detail as possible for your timetable during the planning stages of the convention.

Programming Committee Clarification Motion

Classification: Time-Frame Policy Motion

Motion: To approve the Board-approved clarification to the Programming Subcommittee language in the GNYRCNA Convention Policy & Guidelines as a time-frame policy motion, replacing the current first duty paragraph with the clean replacement language below.

Intent

To clarify the formation and participation process for the Programming Subcommittee before planning begins for the 2027 Convention. The current policy directs the Programming Subcommittee to recruit members and make reasonable efforts to include representatives from each Area, but questions have arisen about how Area participation should be requested, how Area representatives and alternates may be selected, and whether participation is limited only to Area-recommended members.

This clarification preserves Area participation as the preferred starting point while also making clear that Area recommendation is not the only path to service. Because the Programming Subcommittee is expected to begin meeting soon for the 2027 Convention, this motion is submitted as a time-frame policy motion so the committee can begin its work with clear direction before programming, speaker selection, workshop planning, and schedule development begin.

Current Paragraph to Be Replaced

Recruit members of this subcommittee. Reasonable efforts shall be made to include representatives for each Area on the region subcommittee.

Clean Replacement Language Submitted for Approval

The clean replacement language below is the language being submitted for approval.

A. To encourage Region-wide participation, each Member Area is strongly recommended to send one (1) representative and one (1) alternate to the Programming Committee. Areas may use whatever method they choose to select their representative and alternate.

Area recommendations are strongly encouraged, but it is not the only way to serve. Within one year of the upcoming convention, if, by majority vote, the voting members of the Convention Committee determine that the Areas have not provided sufficient participants for the Programming Committee to properly function, the Convention Committee will open membership on the Programming Committee to the Greater New York Region fellowship at large.

Motion: that the dispersement of \$95,000.00 to the Impossible Dream Convention 3 be held until such time that Region Service Committee can receive more information until clarity can be obtained as to the definition of "seed money" in the convention policy for financial obligations to be met. Provided that any upcoming scheduled payments will be paid.

Rational:

Seeking clarity on the below convention policy article XII and the definition of seed money before the RSO BOD's dispersement of \$95,000.

ARTICLE XII: POST CONVENTION PROTOCOLS

Section 1: Proceeds: After each Convention, a prudent reserve of a minimum of twenty-five thousand dollars (\$25,000.00) over and above pre-registrations shall be maintained to finance the next Convention ("seed monies").

The Convention Policy states that the GNYRCNA 2027 The Impossible Dream 3 is allowed to maintain a minimum of 25,000.00 in "SEED MONEY". SEED MONEY is an amount of money to address the initial expenses related to the future event and are not intended to cover nearly the entire expenses related to the convention. That is why the the policy states "SEED MONEY".

To further complicate the reporting to the RSC, neither the BOD nor the Convention Chair have provided sufficient information concerning a time line for when the future convention expenses are due. They also have not calculated into their reports the monies that will be generated prior to the start of the The Impossible Dream 3 Convention. Due to these omissions in reporting the Greater New York Regional Service Committee cannot fulfill its responsibility of reporting to the Areas within the Greater New York Region.
