REGIONAL CONCERNS: Insurance, groups in our region have been questioning why virtual groups need to pay insurance. It was explained by the RSO that the regional insurance policy is by a geographical area and not by individual in person groups. Since it is the area that pays the insurance premium to region if groups in the area do not donate it actually increases the cost for all meetings.

Why should we care about insurance?

Most facilities today have insurance policies that do not extend coverage to organizations to whom they rent their facilities. Often, this is a requirement from their own insurance policies. As a result, facilities can refuse to rent or lend their available spaces, unless given specific, verifiable assurance of insurance coverage. This coverage would apply to any accidents, injuries, or damage that may occur while their facility is in use by another organization (like an NA Group or Event/Activity).

What kind of insurance assurance / policy is required? These types of policies are called "General Liability Insurance".

What is General Liability Insurance? A standard insurance policy issued to business organizations to protect them against liability claims for bodily injury (BI) and property damage (PD) arising out of premises, operations, products, and completed operations; and advertising and personal injury (PI) liability

How do Groups obtain this coverage?

Because it is very expensive to obtain this coverage on a per-Group basis, the Greater New York Region maintains this insurance policy, through its Regional Service Office, providing this coverage to all the meetings listed as GNYR meetings.

Who pays for the insurance?

Each Area identifying itself as a member of the Greater New York Region pays a monthly amount that is part of the total premium, and is based on the number of meetings that identify themselves as members of that Area. At the July Regional session, the RCMs are requested by the Region to ask their Areas to ensure that their Area's section of the online Regional meeting list is up to date so that the Region has an accurate count of the number of meetings per Area. The sum total is then given to the Insurance Agent who calculates the total yearly premium based on the number of meetings. That information is then given to the Treasurer of the Regional Service Office, who calculates each Area's portion based on the number of meetings in their Area and divides it into 10 (ten) monthly payments. The Areas must begin paying in October (our policy runs yearly from October to October).

Why do Groups need to obtain an Insurance Certificate?

Your meeting may be covered by the GNYR's Insurance Policy but the facility in which your group meets may require proof of this before they allow you to use or continue using their facility.

GNYRSC RD Team January 2022 RSC Report

I. Conference Participant December Webinar

The RD and RDA attended a Conference participant web meeting on December 18, 2021. The meeting primarily focused on the Interim CAR/CAT that was posted to the World Services Conference page in November at www.na.org/conference. The document is also being distributed with this report. The time was reserved for questions and answers regarding the CAR/CAT. Given the straightforward nature of the items in the CAR/CAT this cycle, the web meeting finished early due to a lack of questions.

II. Interim World Service Conference 2022

As reported to RSC participants at the RSC last November, the World Service Conference will convene for a partial, interim, virtual meeting in 2022 to make decisions that are required by law and policy, as well as to decide on the Spiritual Principle a Day book, but the conference cycle this time will be three years, ending when the 2023 meeting closes. The required business that will be considered is as follows:

1. NA World Services Budget for one year – 2022-2023
2. Extend existing FIPT moratorium on inspection clause for one year. (Acting as the trustor, the delegates present at the virtual WSC 2022, are continuing the suspension of Article 5, Section 3 of the FIPT Operational Rules, while we make a decision about the future. This suspension will expire at the close of WSC 2023.)
3. Adjustment of terms for WSC trusted servants until the 2023 WSC.
4. Approval of the Spiritual Principle a Day book.

As reported last November, in light of the foregoing, it does not seem necessary to hold Area CAR Workshops as would be the case for a normal WSC. The Budget is not an item that the fellowship as a whole considers. The second item is a housekeeping item necessitated by the extension of the conference cycle. The third item has been recommended by the World Board and is supported by the RD team and does not seem to lend itself to a Regional group conscience. The fourth item is an up or down vote on a major piece of literature that has been in development for 4 years. The RD Team will carry the conscience of the Region's groups submitted to the RD team by the RCMs at the March RSC.

However, as we offered in November, we will take direction from the RCMs if you want to take a different approach. There are Power Point presentations on each of the items available at www.na.org/conference that RCMs can use to explain the items to the GSRs in their Areas if that is felt to be necessary. Given that we have not heard from any RCMs since we reported in November, we have assumed that you agree with our previous suggested approach.

Regarding approval of the Spiritual Principle a Day book, it is included with the Interim CAR/CAT, which is an electronic document posted on www.na.org/conference. It is also being distributed with this report. At the December web meeting, World Services reported that in their haste to get the draft posted and printed, they inadvertently left a chunk of entries (from compassion to empathy) out of the

table of spiritual principles that appears at the end of the draft. This was corrected in a subsequent Approval Draft on the conference page, www.na.org/conference.

In addition, just prior to the December Web meeting, an NA member let World Services know that they inadvertently duplicated one of the entries in the approval draft of A Spiritual Principle a Day. The 29 May entry for vigilance is a duplicate of the entry on 2 November. World Services had circulated five different entries on vigilance for Fellowship review. They intended to include all five in the book, but only four made it into the approval draft in the CAR, with one of the four repeated. Conference participants were polled at the December Web meeting to ask how they thought World Services should proceed. The overwhelming majority of participants responding to the poll (more than 90%) felt World Services should replace the duplicate entry with the fifth entry on vigilance that went out for review.

The World Board had an email exchange after the Conference participant web meeting and confirmed that they are in consensus to replace the entry. Accordingly, World Services has corrected the draft that is posted on the conference page www.na.org/conference and posted the corrected entry for 29 May as a separate file as well at www.na.org/conference. The corrected draft has January 2022 on the cover and is being distributed with this report.

The corrected approval draft is also available for purchase from the NAWs webstore (www.na.org/webstore) as a tape-bound draft for \$10 plus shipping and handling. As was indicated by RSO representatives at the last RSC, the RSO will only order hard copies that are specifically requested by members to avoid having excess unsold inventory.

Finally, included with this report is a World Services Contributions report that provides information about contributions to World Services including from the GNYRSC.
