- Treasurer (vacant), Report given by Chairperson (attachment 8)
 Discussion:
 - -PR Chair asked who is creating the Treasurer's report.
 - -Chairperson replied Dana is still on the account and creating the Treasurer's report until there is a new Treasurer.
 - -PR Chair asked how many people do we need right now to move money.
 - -Chairperson said Troy, Thomas & Dana are the current account holders. When there is a new Treasurer we have to change the names on the bank account and Venmo. Due to the way Venmo works, only one person can be associated with the account by their phone number...we haven't found a way to add more than one person on the electronic accounts.
 - -The Technology Chair said with our bank account we can withdraw money with two signatures. But with virtual the money is transferred, and the account is under one phone number. When it comes to anything virtual (Venmo, Zelle, Cash App, etc.), the account is associated with one phone number. You cannot use a Google number or any virtual phone number.
 - -Shanda said no one person should be responsible for the Area's funds.
 - -The Technology Chair said using an EIN# should take care of all of these issues, as we are a business, not a non-profit.
 - -Time to Live & Give said in the policy it says that checks written out require 2 signatures and were completed ONLY at Area by the close of business. She suggested that outgoing expenses such as paying bills/sending checks should be done traditionally with the 2 signature bank account, but incoming money from donations, literature etc. could still be taken via Venmo.
- Hybrid Ad-Hoc Report given (attachment 9)
 Discussion:





-Step Up to the Deck asked if there is a projected start date for "hybrid" (meaning both sides can see each other).

-Ad-hoc Chair replied she can bring her own personal equipment to Area next month as a trial. She would like the Area to purchase this equipment at some point for the Virtual Liaison to use going forward. The ad-hoc committee determined this was feasible and she would like the Technology subcommittee to take over.

-Chairperson says we're going to stay hybrid 6 months so we can figure this out. Back to Basics motioned to accept, Together on Sunday seconded. Accepted.

Motion Maker: Back to Basics

Motion: Staten Island Area Steering and Area service meetings be held hybrid (in person and virtually) for as long as the Staten Island Area have groups meeting virtually.

<u>Intent:</u> In accordance with concepts each member should be allowed to fully participate in the decision making process.

By having the service meetings hybrid all members would have that access.

Concepts Referenced:

<u>7.</u> All members of a service body bear substantial responsibility for that body's decisions and should be allowed to fully participate in its decision-making processes.

8. Our service structure depends on the integrity and effectiveness of our communications.

Financial Impact: \$15.00/month, which the Area has paid the last 2 years.

Policy Affected: We have no policy on the issue-We have no policy on Area service or Steering meeting hybrid. This would become policy and would need 2/3 votes to pass. Clean Times said the ad-hoc committee answered his question.

The ad-hoc committee has provided answers on this motion. It will be voted on next month.

Motion Two

Motion Maker: Steps to Freedom

<u>Motion:</u> Put into policy that all Area level commitments, including sub-committees must attend Steering and Area in person.

<u>Amended Motion:</u> Put into policy that all Steering Committee members must attend Steering in person, and all sub-committee Chairs/Steering committee members must attend Area service in person.

<u>Intent:</u> To bring unity to the Area. We believe that business can be conducted much more effectively if all committees attend and meet in person. We would like to see Area and Steering eventually meeting in person, doing away with the hybrid format.

<u>Tradition #1</u> Our common welfare should come 1st; personal recovery depends on NA unity. <u>Policy affected:</u> None- no policy currently in place. This would be new policy.

<u>Financial impact:</u> None, as there is one Zoom account for the Area being used by meetings and sub-committees.

-Motion maker isn't in attendance...motion dies due to lack of support.
