So \$258.50 went to our set aside money that will be used for our BBQ/free event and \$258.50 was donated to our area. Thank you ALL so much for showing up and attending! We had a full house and everyone had a great time. I would like to thank Gary and his amazing group of volunteers. The food was great. This was such a hard working group of people who never stopped preparing and serving. They did it all with a smile. Thank you! I would like to thank our volunteers who also showed up at 6 am to unpack the trucks, set everything up and clean up afterwards. You are wonderful and hard working. There were people here that day who volunteered and worked with us, before they had to go to their actual jobs, and those who came after their work was done. There were others who spent time away from families to come and do service. Thank you to our fantastic speakers, we appreciate you and your message of spiritual service. Thank you to those who couldn't come and bought tickets for others. Thank you to the committed ticket sales people! you guys did such a great job! And last but not least, a big thank you to our amazing committee members. This committee works so hard. We are small but strong and I could not ask for a better group of people to do service with. I truly appreciate you all.

So now, we come to the part of the report I am unhappy about. As some of you may know, there are going to be a lot of changes happening within All Saints Church and its hall. **We went into the circuit box and left the doors open.*

**We id not clean up sufficiently, put the tables and chairs away correctly clean floor properly, or secure the garbage correctly.*

**The committee members did nothing to help clean up, but we watched the person making the complaints clean up alone while we sat around a table laughing and counting money.*

The person who made the complaints did so not only to Gary from the church but in front of one of overseeing committee members. This person was not a part of the subcommittee and was not there for the setup of the event. We had several people opening up at 6 am, myself and Candy were among them. and here is what actually happened:

**When we got into the hall, at 6 am, all of the electrical outlets in the hall itself were not working from the very beginning. The set up crew had to start and stop using the griddles to cook on. They spent the morning trying to go back and forth, for each item to be cooked one at a time. Our volunteer in charge of the pancakes actually had to sit on the other side of the room to make them, practically sitting on the floor. Even the coffee pot had to be stopped mid-brew to accommodate other items being cooked. It was a terrible situation to walk into and everyone worked hard making the best of it. The microwave did not cause this. IF a member used the microwave, we did not know about it. However, the group knows not to us the microwave. It is put away in the smaller office.*

**Yes, we had members check the fuses and accidentally left the door to the fuse box open. and, it is possible that someone tried to use the extension cord, out of desperation, to find a good power supply. It may have been what caused the phone line to be unplugged. We took responsibility for both of those things. We did no sit back and leave a dirty hall nor did we watch one person clean the floors, take out the garbage, or put all the tables and chairs away. There was a group of 11 people on clean up, who were told by the complainant that they were they only one who would have to hear it if things weren't done right. So they wanted to "help" put the tables away, mop the floors and would not let them finish putting the garbage out into the pails without their final fixing.*

**At that time, those of us at the table were only counting the money, tallying the receipts, and making sure all the numbers were triple checked. We were actually grateful that the now complainant was there because we had no access to the mops or brooms.*

as a result of this, we will now make two changes. First, we will buy our own cleaning supplies and bring them to and from events. Second, we elected a Serenity Keeper Chair, and he will have a committee of men and women to watch over any facility we rent to make sure that no one goes or does what is not allowed.

What will happen after this, we are not sure. Gary from the church apologized to Candy and said that he took what the complainant said as true, and they alluded that they were there from the beginning and saw all of the things happen first person. So, once Candy explained what happened with the electricity, among other things, he asked that she write a statement and email it so he could show the oversight committee and hope they would get a better picture of what happened. He did say he saw what looked like marks from the microwave on the table in the bigger office. Other than that, he saw nothing else wrong at all.

The end results are that the oversight committee just let Gary know at the end of last week, they are not allowing any new events at the hall. We lost our space for the game night, even though the date is free on the hall's schedule. This may be because the oversight committee is trying to get a handle on how Amy used to run things and are trying to sort things out, or it could be because of the unfavorable report. We do not know. Candy is contacting several halls, trying to find a new place to have the game night. There are currently two more places that are going to get back to her within the next two days. she had made herself available in case the oversight committee wants to ask her any questions about that day. she also gave Gary information about who to contact if he needs information or has questions. He already has the policy chair's info for steering committee, & general questions. He has Candy and Larry's info for E&A and H&I subcommittee issues. He does want to keep our relationship with the hall and has told their committee that we have always had a wonderful relationship with them, and feels it should continue in the future. sorry to have to put this all in my report. I felt it needed to be discussed. Our committee met last month to go over our past two events, and are looking forward, hopefully, to host our pasta game night, to do hospitality for the upcoming H&I/PI learning day, and continue to plan for the rest of our events. we are going to contact the people who came to the learning day. We will invite them to this months' sub-committee meeting on Tuesday May 27th. It will be hybrid. Thank you to the technology committee and the steering committee for creating and approving our flyer. Hopefully as soon as possible we will have a location. Sorry to have such a long report. On a last happy note, please help us congratulate our new Serenity Keeper Chair, Carmine! Thank you Carmine, you are very much welcomed and appreciated. Thank you all.
