Board of Officers

The Board of Officers is the primary governing body of a Moose Lodge. It typically includes the following voting officers:

- **Governor (President):** Leads the lodge, presides over meetings, and represents the lodge externally mooseintl.org+1.
- **Junior Governor (Vice President):** Assists the Governor and assumes duties in their absence mooseintl.org+1.
- **Prelate (Chaplain):** Oversees rituals, ceremonies, and spiritual guidance mooseintl.org+1.
- **Junior Past Governor:** Provides continuity and advice based on prior experience mooseintl.org+1.
- **Administrator:** Manages day-to-day operations, records, and correspondence mooseintl.org+1.
- **Treasurer:** Handles financial matters, including dues, budgets, and reporting mooseintl.org+1.
- **Trustees:** Oversee property, assets, and long-term planning mooseintl.org+1.
- **Appointed non-voting officers**, such as:
 - Sergeant-at-Arms:** Maintains order during meetings
 - Inner Guard and Outer Guard:** Manage lodge security and ceremonial duties
