In the Year 2003


Some 57,000 crashes involving passenger vehicles towing trailers occur annually, according to five-year averages of accident analysis by the National Highway Traffic Safety Association. In 2003 alone, accidents with trailing vehicles resulted in 364 deaths, 14,484 injuries and 40,080 instances of property damage. Both the numbers of deaths and property damages increased in 2003 from the previous year.

In The Year 2004

More than 65,000 crashes involving passenger vehicles towing trailers occurred in 2004, jumping nearly 20 percent from the previous year, according to the National Highway Traffic Safety Association. In 2004 alone, accidents of vehicles with a trailing unit resulted in 422 deaths, 27,332 injuries and 46,737 instances of property damage.

An Increase of nearly 20 percent over the previous year. So what does our government do? They stopped keeping track. Not Us.

In just one year enough people are killed due to loose trailers that can fill up a 747 airplane.

Summary of an accident in Richmond
In summary, this crash was caused when a homemade trailer detached from the pick up that towed it. It struck a Cadillac traveling in the opposing lanes of traffic, fatally injuring the driver. Trailers are a special class of vehicle and all are subject to some requirements regarding lights and chains. While the Code exempts some smaller trailers, those designed to carry over 3000 pounds are required to have brakes and to be inspected beyond the initial visual confirmation of a vin Plate

However, Virginia State Code is silent as to any design or construction specifications for those vehicles or for towing chains and hitches for any trailer under 3,000. That is why they weigh about 5 pounds under this limit.

The same problem exists In almost every state!
