2019-2020 competition & exhibition

eligibility

The Five-State Photography Competition & Exhibition is a regional fine art competition open to any photographer living in Kansas, Missouri, Nebraska, Oklahoma and Colorado. Any photographic process is eligible as long as it is original work created during the last three years and **has NOT been exhibited in a previous Five-State Exhibition.**

specifications

There are no size restrictions, however **all entries must be framed and/or mounted suitably for professional gallery presentation – with secure hanging device (wire preferred).** It is the artist's responsibility to provide appropriate surface protection for their photographs; glass, plexiglass, laminate surface, etc. Neutral matting and framing are recommended. Sculptural forms and diptychs or triptychs (as multi-framed single entries) are **not** eligible.

categories

When filling out the entry form, the artist must choose in which of the categories each piece is to be entered and ultimately judged: **1. Nature; 2. People; 3. Open.** Any process is eligible in any category. For our information and to better serve visitor interest, you may include any special process information on the back of the entry (not required).

entry form & fees

A fee of \$20 will allow the entry of two works. Two additional works may be entered for a fee of \$5 each. Entry fees are non-refundable. Checks are to be made payable to the Hays Arts Council.

Please fill out (PRINT OR TYPE) the entry card, notification card, and identification tags, which are to be attached to the back of each entry. **You must affix a stamp to the notification card for its return.** Be sure to include method of return delivery and insurance value of all works. Forward or include your entry card and notification card with fees. **Entry forms and fees are due by November 8, 2019.**

delivery

All shipped works are to be sent in reusable packaging (**No Packing Peanuts**). Please allow ample time for entries to reach us. All hand delivered works will be accepted Monday through Friday, 10 am to 4 pm. **All entries must arrive no later than Monday, November 11, 2019.**

return

Hand-delivered entries not accepted by the jurors may be picked up beginning November 26 - and if accepted, at the conclusion of the exhibit. Without advance arrangements, work may be picked up ONLY during weekday gallery hours of 10 am - 4 pm. The Hays Arts Council will not be responsible for works left after February 15, 2020. **Unless exact, return postage including insurance is included with entry, carrier-delivered entries will be returned collect (insured at the value listed) via the original mode of delivery.** If all works are declined, they will be returned the week of November 26; otherwise, they will be returned at the end of the exhibit.

juror

UPDATE: Due to a scheduling conflict by our original juror, **John Finch**, who served as juror a few years ago, will curate this year's show. Finch has been a professional fine art, nature, and portrait photographer for over 40 years, with numerous awards and publications to his credit. He is a recognized "master photographer" with extensive experience judging professional and amateur photography competitions, as well as an experienced instructor in photography and darkroom development.

awards

The jurors will bestow cash awards of \$1,500, divided among the categories: Nature, People & Open (with no categorization of process).

sales

The Hays Arts Council will retain a 33 1/3% commission on all sales of work accepted into the exhibit. Please take this into account if designating a sale price. Payment for sold works will be made at the conclusion of the exhibit.

liability

Utmost care and handling will be given to all entries. However, the Hays Arts Council and the sponsors of the exhibit will assume no responsibility for the loss or damage to any work entered. All individuals working with this exhibition shall be held blameless for any and all liabilities arising from this exhibition. The Hays Arts Council shall assume the right to reproduce any entry for catalog or publicity purposes related to this exhibition or future exhibitions. The return of the entry form constitutes the artist's agreement with conditions set forth in this prospectus.

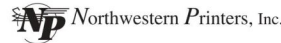
catalog
