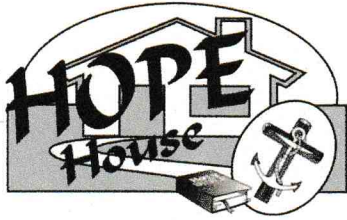


Dear Pete,
