Registration fee

This is a once a season fee to reserve your child's spot in class. Registration is not complete and a space in class is not reserved until this fee along with first months tuition has been paid. \$40 per dancer or \$70 per family

Class Fees

- Class Fees are due between the 1st and 15th of every month.
- A \$10.00 late fee will be applied to all accounts not paid by the 15th of each month.
- Tuition may be paid by the following methods: Cash, Check, Credit/Debit (2.5% fee applies), Online at www.idancefowler.com
- Checks should be made out to iDance Co. with your child's full name in the memo. There is a \$20.00 return check fee, per check, on all returned checks.
- Tuition remains the same regardless of absence and whether it is a long 5 week month or a short 4 week month.

Class Instruction

Children receive a 45 minute instructional period which includes but is not limited to:

- Stretching
- Learning specific dance terms and moves
- Technique for that particular dance style
- Choreography for the dance recital dance
- Individualized attention to help all children understand and execute moves correctly
- Learning how to count beats
- Learning multiple types of choreography pertaining to that particular dance style

Costumes

Costumes are ordered at the beginning of November to avoid any back ordered shipments. All children are measured individually and costumes are custom made to their measurements. Children will not receive their costumes unless all fees associated with the costume have been paid for. Costume money is due before the end of October. (All competition classes fees are due the end of September) If all fees are not paid your child's costume will not be ordered until payment is made. COSTUME PAYMENT IS NON REFUNDABLE since I cannot return custom made costumes.

Dropping Classes

Children are allowed to drop a class within the first month of instruction. After that all children are permanently placed in their respective class for the remainder of the dance season, and all fees associated with that class will apply. If you choose to drop a class you will be pro-rated at the time of cancellation. **Not showing up to class is not grounds for dropping class.** A "**DROP CLASS**" form must be filled out and kept on file. All accounts will need to be brought to current before the drop is final. Dance is a 10 month commitment. Dropping after the Christmas holiday will still require you to pay all fee's associated with your child's account.

Recital

All students are expected to perform in the recital. Recital is typically held in June after kids have gotten out of school for the summer. All dancers are required to sell 10 tickets for recital families with 2 or more students are required to sell 15 tickets. Dancers and their mother (or female guardian) receive a free admission into the recital. All dancers are expected to participate in dress rehearsal usually the day before the actual recital performance. Recital and rehearsal dates will be provided to you. All outstanding account costs will be settled and closed before recital or else the dancer will not be able to perform. This includes; ticket sales, monthly tuition, costume fees, and late fees.

Pictures

Dance pictures will be available for purchase before dance recital at the "Picture Day." All dancers are required to be there for pictures but it is not necessary for parents to purchase pictures. Photographer will be an outside service and payment will be made directly to them.

Insurance

iDance Co. does not carry medical insurance for its dancers. It is required that all students be covered by their own family insurance policies and if injury occurs it is understood that the students own policy is your only source of reimbursement.

Holidays

iDance Co. will be closed for the following holidays:

- Thanksgiving week
- Christmas week (Week between Christmas and New Year's)

- Presidents Day

Attendance

Good Attendance is imperative, as absences and tardiness can hold back an entire class. Students should be prompt and prepared for class with appropriate clothing and shoes ready before instruction begins.

Practice Wear

Dance wear is required for all classes. Students must wear comfortable form fitting dance attire to display proper body alignment and allow for easy movement. No baggy t-shirts, baggy shorts, blue jeans, no costume jewelry or other inappropriate attire will be allowed. **Hair should be always securely pulled away from the face.**

The following **All Black** clothing is suggested for all classes:

- **Ballet-** leotard, tights, **pink ballet shoes**, skirts, wraps, shorts over tights or tutu's are allowed. We must always be able to see the knees. **NO DANCE PANTS FOR THIS CLASS PLEASE.**
- **Tap-** Any type of form fitting clothes appropriate for dance class that is not constricting and allow for full range of motion. **Black tap shoes are necessary.** Dance pants, capris, leggings, and shorts are all allowed.
- **Jazz/Musical Theatre-** Any type of form fitting appropriate dance wear such as dance pants, shorts, capris, leggings, leotards, sports bras, or form fitting tee shirts. **Tan Jazz Shoes or dance paws are necessary.**
- **Contemporary-** Same attire as ballet
- **Hip-Hop-** Tennis shoes, and comfortable clothing

Studio Rules

- No students should be in the studio unless enrolled in that particular class.
- Students should be dressed and prepared for class before it starts.
- No street shoes in the studio unless in the lobby area (except for hip-hop class)
- No food or drink is allowed passed the lobby area. Water is the only beverage permitted in the studio.
- Chewing gum is NEVER allowed in the studios.
- Observation of classes is allowed, but observers must be quiet to not interrupt class instruction.
