DeLand Planning Board to discuss nearly 200-acre housing development tonight

The DeLand Planning Board will discuss Trinity Gardens, a newly proposed housing development on the city's southeast side at 5 p.m. tonight, Dec. 15.

The development, called Trinity Gardens, is a 183.92-acre proposed development that would be located at 791 S. Blue Lake Ave., north of the <u>planned extension to East Beresford Avenue</u>. The project would span from Blue Lake Avenue east to South Kepler Road.

Initial planning documents for the development call for the construction of 425 single-family homes and 118 town homes. The single-family homes would include 330 units on 50-foot-wide lots and 95 units on 60-foot-wide lots.

The DeLand Planning Board will discuss Trinity Gardens, a newly proposed housing development at 5 p.m. tonight, Dec. 15.

The development, called Trinity Gardens, is a 183.92-acre proposed development that would be located at 791 S. Blue Lake Ave., north of the <u>planned extension to East Beresford Avenue</u>. The project would span from Blue Lake Avenue east to South Kepler Road.

Initial planning documents for the development call for the construction of 425 single-family homes and 118 town homes. The single-family homes would include 330 units on 50-foot-wide lots and 95 units on 60-foot-wide lots.

The land is owned by the Stewart family. Tom Stewart once owned the land the Victoria Park development is now built on.

The request to rezone the area to a PD, or planned development, comes from applicant Hanover Land Company LLC., represented by attorney Michael Woods of Cobb Cole. The company is also requesting the annexation of three parcels totaling roughly 64 acres to complete Trinity Gardens' acreage. One parcel is near South Kepler Road while the other two rest along South Blue Lake Avenue.
