

Dear Jeremy,

In the blink of an eye, the month of July has come and gone. I hope that you have been enjoying your summer and have been taking in all that Southwest Saskatchewan has to offer, just as I have been. Over the past four weeks, I have travelled to every corner of the constituency, and have been able to connect with many of you at community parades, markets, and events.

In my travels, I am hearing a very consistent theme of frustration with this Federal Government—a feeling that I share. Over the past seven years, hardworking Canadians such as farmers, business owners, and energy producers are feeling as though they are being taken advantage of by the Trudeau Liberals, and that this government doesn't have their best interest at heart. I assure you that as your Member of Parliament, I understand and will continue to tirelessly hold this government to account for its multiple failures.



This summer has also been unique as a few of the House of Commons standing committees are still sitting to get to the bottom of more Liberal scandals. My

Conservative colleagues have been doing an amazing job at holding the Liberals feet to the fire on these issues. I will share more about this below.

In my travels, a few of you have also raised the possibility of a Fall election. While this is just rumours at the moment, in either case, Conservatives will be ready to fight an election and are ready to form a strong Conservative government. The Conservative Party will also be completing its leadership race in time for the Fall sitting of the House of Commons and will be ready to form another strong opposition to the Trudeau Liberals.

Supporting Local Agriculture

As farmers are gearing up to head into the fields to harvest this year's crops, I am hearing more optimism for this season. While on the whole we have been blessed with cooperating weather and growing conditions that are favourable to maximizing yields, I do understand that many are still in a position where they are suffering. As farmers take their cops off over the next month, I will be an open ear and when we return to the House of Commons in the Fall, I am prepared to fight for proper supports for those dealing with the effects of drought.



However, amidst a good crop year, I do know that farmers are still dealing with sky-high input costs. Already back in January, I raised this with the Agriculture Minister and have been calling on the government to establish proper supports for farmers. Among these input costs has been the cost of fertilizer. Contributing

to this was Canada's decision to impose a retroactive tariff on Russian fertilizer that was purchased before the war even started, a massive and unfair burden on our farmers. I have exercised my voice as an MP and have consistently called on the government to support farmers and drop this retroactive tariff.

With fertilizer in mind, it also brings up the question of the proposed 30% reduction in nitrogen fertilizer emissions. While this plan appears to be different from the hard reduction in fertilizer usage imposed in the European Union, the Liberals have refused to clarify. I began raising this issue already last Fall, and have pushed for more clarity as to what this plan means for Canadian producers. The Liberals have skirted around the question, and have not provided any clarity. In either case, my Conservative colleagues and I will not tolerate another attack on our producers and will continue to support the amazing work our farmers are doing to care for the environment.

I have also been working to support farmers by introducing my Private Members Bill, Bill C-294, the Unlocking Innovation Act. If passed, this Bill will allow for more competition in agriculture implements by allowing for interoperability, a key step that will contribute to lowering the price of agriculture implements.
