Political Interference and the RCMP

Following the shocking news of alleged political interference between Minister Bill Blair and RCMP Commissioner Brenda Lucki, many questions remain unanswered.

Both of them denied it before the Public Safety committee back in July, but more recently those involved from the Nova Scotia RCMP doubled down. In an opening statement to the same committee, Chief Superintendent Darren Campbell went so far as to say, "[Lucki] didn't seem to appreciate or recognize the importance of maintaining the integrity of an investigation." Lia Scanlan, who has previously corroborated Campbell's story and appeared alongside him,

likewise felt that Lucki did not care about the risk to the investigation.

Meanwhile, at the ongoing Mass Casualty Commission in Nova Scotia, something else came up.

Another Chief Superintendent named Chris Leather had not shared communications related to the original meeting with Lucki because he said federal Justice Department had advised not to proactively disclose such information. In response, the commission's counsel director (and former Supreme Court Justice) publicly called for the department to give assurance that this type of advice will not be given to other witnesses and potentially compromise the inquiry.

As an aside, Commissioner Lucki also appeared at the Mass Casualty Commission to testify as part of the inquiry. Those of you who are legal firearms owners and familiar with the process will particularly want to see her response when asked about laws surrounding licenses. Would it be any surprise if Liberal ministers keep trying to push their misinformed restrictions and policies?

Governments Response to E-Petition

The Liberal Government has officially responded to E-Petition 3873 which garnered over 17,500 signatures and called on the government to scrap their vindictive vaccine mandates for Public Service workers.

In their response, they noted that “On October 21, 2021, the Canadian Human Rights Commission published a guide on vaccination policies and human rights, which states that ‘Rights are not absolute. [...] Requiring that an individual be vaccinated to work or travel is not a discriminatory practice under the Canadian Human Rights Act. Vaccination requirements are not a discriminatory practice because they are intended (and are necessary) to protect public health and safety.’”
