




**A Message from Jeremy:**

#### ICYMI - Clare's Law Petition:



Some of you might have heard that recently the Saskatchewan Government unanimously passed the *Interpersonal Violence Disclosure Protocol Act* (Clare's Law) which would protect citizens from domestic abuse by allowing them to be informed of an intimate partner's past violent or abusive behaviour, including criminal convictions and a history of police responding to domestic violence complaints.

However, a clause under the Federal *Privacy Act* prevents the RCMP from being able to enforce this law. As such, I sponsored a petition which calls on the Minister of Justice to make the necessary changes to the *Privacy Act*, that will allow the RCMP to enforce the law.
