INAUGURAL MEETING



On 11 May 2022, SGListCos (Association of all Singapore Listed Companies) was launched. Representatives of the 20 founding members gathered for the inaugural meeting held at SGX Centre and discussed their hopes and vision for the association. SGX Group CEO, Loh Boon Chye, also expressed his support for the association by announcing that SGX Group will incubate SGListCos until the association is fully independent.



MOU SIGNING WITH ISCA

DEDICATED SGX ESGENOME **SHARING SESSION**



ESGENOME: MAKING DISCLOSURE EASY & ITS EVOLUTION

In Oct 2022, we invited the SGX ESGenome team for a dedicated sharing session of the ESGenome portal for our members.

ESGenome is a joint initiative by The Monetary Authority of Singapore (MAS) and SGX Group under Project Greenprint to develop a common disclosure utility that will facilitate sustainability reporting for SGX-listed companies.

For investors and financial institutions, ESGenome provides access to relevant and comparable ESG data that allows for meaningful peer benchmarking and tracking of sustainability commitments. This enables capital to be mobilised more efficiently toward sustainable companies and projects.

PARTICIPATED IN ACRA/IPOS INTANGIBLES DISCLOSURE FRAMEWORK FOCUS GROUP

In Jan 2023, members of SGListCos participated in a focus group session conducted by the Intangibles Disclosure Industry Working Group (IDIWG) on a proposed Intangibles Disclosure Framework (IDF).

The IDF is a key initiate of Singapore IP Strategy 2030 to build an enabling infrastructure to support enterprises in commercializing intangible assets. The introduction of IDF will provide private and capital participants with standardised information about companies' intangibles-related risks and opportunities to enable a more informed assessment of companies' business and market financial prospects.







SUPPORTED THE SUSTAINABILITY LEADERS' NETWORK



SGListCos also supported the Sustainabilty Leader's Network event in Aug 2022. The SLN is part of SGX Group's efforts to provide a networking opportunity for Chief Sustainability Officers (or equivalents) to get to know each other and build trust within the network.

Themed "Mobilising Sustainability Internally", speakers from McKinsey and Acre shared with the audience on what are optimal operational set-ups and how should sustainability be integrated into an organisation.

The session then proceeded with a roundtable where the SGX-listed companies' CSOs shared candidly on their operational models and experience, before ending with wine and snacks from sustainable sources.





PARTICIPATED IN ISCA PRE-BUDGET ROUNDTABLE

The 14th ISCA Pre-Budget Roundtable 2023 took place at ISCA House on 19 January.

Themed "Stepping Forward amid Megatrends", leaders from various trade associations and chambers and accounting entities were invited to provide on-ground feedback and insights from the business community on how the Singapore Budget 2023 can provide support to drive recovery and growth. Our Protem Chairman Mr Chew Sutat was invited to sit on ISCA's pre-budget 2023 roundtable. The roundatable is organised annually to gather the views and insights of business leaders on how the Singapore Budget can be shaped to advance the nation's future.

Co-chaired by Liang Eng Hwa, Chairman, Government Parliamentary Committee (Finance, Trade and Industry) and Mr Don Wee, ISCA Council Member and Member of Parliament, the Roundtable gathered 14 representatives from various trade associations and chambers (TACs) and accounting entities. Inputs at the Roundtable and key points raised are shared with the Ministry of Finance (MOF) for their consideration in the Budget 2023 formulation.

SGListCos members were surveyed prior to the Roundatable and feedback were gathered around the themes of (i) Sustainabiliy, (ii) Digitalisation; and (iii) Diversification.

Points Raised:

- 1. Easier PR for long time employees
- 2. Relief for Green Loans
- 3. Cross-border digital real time payments
- 4. National Cyber Incidence & Response
- 5. Increase pathways for SME Equity Capital
- 6. Create a sustainability "mark"
- 7. Incentives for SME ESG adoption and many more...

Six Initiatives

1. SME Financing & Capital Markets Paper

The objective is (i) Identify pain points for local SME financing, including capital markets; and (ii) Develop Singapore as a regional SME funding centre.

2. Renewable Energy Certificates (RECs) Guidance Paper

Objectives are (i) To provide guidance and checklist for selection of projects; (ii) Safeguard listcos against accusation of greenwashing and (iii) Provide guidance for diclosure for IR & PR.

3. Investor Relations Professional Development Workshops

Boost Investor Relations' Professional Development via specially curated workshops & courses.

4. Investor Outreach Programme (Retail & Institutional Investors)

The specially curated investor outreach programme is designed to profile our members to targeted investors.

5. Efficient ESG Reporting Advocacy Group

The EERAG will identify any pain points in using key ESG reporting platforms (eg. SGX ESGenome) and provide feedback on how it can better serve listcos' needs.

6. ASEAN Taskforce on Naturerelated Financial Disclosures (TNFD) Consultation Group Workshop

To learn and input into a framework to assess nature related risks and disclosures.
