**ENTRY SHEET / WAIVER of LIABILITY**

I also certify that the entrant has no injuries or health considerations that would preclude wrestling in this tournament.

I/WE fully understand and acknowledge that:

A) there are risks and dangers associated with the participation in the Rustburg Youth Open Wrestling Tournament which could result in bodily injury, partial and/or total disability, paralysis and death.

B) These risks and dangers may be caused by the action, inaction or negligence of the participant or the action, inaction or negligence of others including but not limited to the Releases named below.

C) There may be other risks not known or that are not reasonably foreseeable at this time.

I/WE HEREBY RELEASE, WAIVE, DISCHARGE AND CONVEYANT NOT TO SUE: Rustburg High School, Campbell County Parks and Recreation Department, and Fort Hill Kiwanis including its owners, managers promoters, lessees of premises used to conduct Rustburg Youth Wrestling tournament or program, premises and event inspectors, underwriters, consultants and others who give recommendations, directions or instruction to engage in risk evaluation or loss control activities regarding Rustburg Youth Wrestling facility or events held at such facility and each of them, their directors, officers, agents, employees, all for the purposes herein referred to as "release"... FROM ALL LIABILITY TO THE UNDERSIGNED, my/our personal representatives, assigns, executors, heirs and next of kin FOR ANY AND ALL CLAIMS, DEMANDS, LOSSES OR DAMAGES AND ANY CLAIMS OR DEMANDS THEREFORE OR ACCOUNT OF ANY INJURY, INCLUDING BUT NOT LIMITED TO THE DEATH OF THE PARTICIPANT OR DAMAGE TO PROPERTY, ARISING OUT OF OR RELATING TO THE EVENT(S) CAUSED OR ALEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE FO THE RELEASEE OR OTHERWISE.

EACH OF THE UNDER SIGNED further expressly agrees to the foregoing release, waiver and indemnity agreement which is intended to be as broad and inclusive as permitted by the law of Commonwealth of Virginia and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding, continue to full legal force and effect.
