and/or any project, activity or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with WONDER&WANDER. I understand and acknowledge that this Release discharges WONDER&WANDER from any liability or claim that lor the Volunteer, if different, may have against WONDER&WANDER with respect to any bodily or other injury, illness, death, or property damage that may result from the participation of the Volunteer. I also understand that WONDER&WANDER does not assume any responsibility or obligation to provide financial assistance or other assistance, including,

- 2. Insurance. I understand that WONDER&WANDER may elect to provide group accident or other liability insurance for the benefit of its volunteers. Any coverage so provided will be governed by the policy language. Except to the extent that it may provide such insurance, WONDER&WANDER does not carry or maintain any health, medical, disability, damage or other liability insurance coverage for the benefit of its volunteers, and expressly disclaims any responsibility or obligation to do so. IF I AM THE PARENT OR LEGAL GUARDIAN OF A YOUTH VOLUNTEER UNDER THE AGEOF 18, I UNDERSTAND THAT I AM EXPECTED AND ENCOURAGED BY WONDER&WANDER TO MAINTAIN MEDICAL HEALTH AND ALL OTHER APPLICABLE INSURANCE COVERAGE FOR MY OWN BENEFIT AND THE BENEFIT OF THE VOLUNTEER.
- 3. Medical Treatment. Except as otherwise agreed to by WONDER&WANDER in writing, I hereby release and forever discharge WONDER&WANDER from any and all liability claims, demands and causes of action whatsoever that may arise on account of any first aid or other medical treatment rendered during the participation of the Volunteer with WONDER&WANDER and/or any project, activity or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with WONDER&WANDER.
- 4. Assumption of Risk. I understand that the participation of the Volunteer with WONDER&WANDER and/or any project, activity, or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with WONDER&WANDER may include activities that may be hazardous to the Volunteer. I hereby expressly and specifically acknowledge that I assume the risk of injury or harm for the Volunteerin these activities and release WONDER&WANDER from all liability for injury, illness, death, and/or property damage that may result.

- 5. Photographic Waiver and Release. I understand that while participating in project, activity, or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with WONDER&WANDER, that WONDER&WANDER may film, photograph, or record the Volunteer's likeness or voice (the "Recorded Works"). I do hereby grant, assign, and convey unto WONDER&WANDER all right, title, and interest the Volunteer may hold in and to any Recorded Work made by or on behalf of WONDER&WANDER or made with its consent, during the participation of the Volunteer with WONDER&WANDER and/or any project, activity or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with WONDER&WANDER, including, but notlimited to, any royalties, proceeds, or other benefits derived from such Recorded Works.
