Treasurer's Report: Suzn Stewart reported that the opening balance on January 1, 2023 was \$7,278.25. Revenue year to date was \$7,560.00 from dues and \$1.68 from interest. Expenses year to date have been \$51.87 and the current balance is \$14,788.06.

Charitable Contributions: Mary Jane Peebles reminded the membership about the mission of our organization and announced that our charitable contributions would be increased by \$500.00 in 2023 and we will be sending \$1750.00 to Hilton Head Island Junior Golf and \$1750.00 to LPGA Girls Golf of Bluffton.

Recognition and thank you for 2023 Season included Board members, Division Heads, and Team Captains representing 19 clubs, 35 teams, 1296 rounds, and 534 players. Hole in ones for 2023 were Betsy Lynch, Sandy Krantz, and Laurel Ludden.

Announcement that there will be a new Division 6 for 2024 which will include teams from Spring Island, May River, Berkley Hall, Sea Pines, Sun City, Port Royal, and Callawassie.

Bylaw change recommended for Section 4 Nominations which currently reads

A nominating committee, comprised of three members appointed by the General Chairman, at least one of whom is a past chairman, shall propose a slate of nominees to the membership at the annual meeting. If a vacancy occurs during the term of a board member, that vacancy shall be <u>filled</u> by the General Chairman.

It was recommended to change the word *filled* to **appointed**.

Motion to approve the recommendation was made by Laurel Ludden and seconded by Chris Wiemels. The motion was approved.

- The Treasurer's report was submitted. Beginning balance in 1/1/2022 was \$5324.83. Dues of \$10800 were collected. After expenses, and estimating for Annual Meeting lunch, the projected balance is \$10,286.10 before charity contributions.
- 2. The amount of tip given to the bag crew was discussed and it was decided to double the amount from \$72.00 or \$2.00 a bag to \$144.00 or \$4.00 a bag, following LWGA's increase. The increase will be covered within the current dues amount of \$360.00.
- 3. The 2023 schedule planning is underway, 4 clubs have not submitted. Final schedule will be out shortly.
- 4. A discussion was held about our annual charitable contributions. An increase the amount by \$500 from \$2500 to \$3,000 was approved will be as follows: \$1500.00 to Hilton Head Island Junior Golf Association and \$1500.00 to LPGA Girls Golf of Bluffton.
- 5. Board voted to eliminate from the Standing Rules, XI.A.2., which allowed matches to be canceled due to unseasonably cold temperatures.
- 6. Repercussions for the Division 5 team coming in last place was discussed. Perhaps that team was eliminated and a team on the waitlist moved up. Decision was tabled.
