## **Funded children**

If you take up private paid for hours we will ask for those hours to be paid for in advance to secure your child's place. This will not apply if you are accessing the standalone offer.

All funded rates are worked out in calendar months as opposed to a monthly average.

**From 01/05/2025;**

**9 months + old funding entitlement for eligible working parents: 11 hours per week (22 hours from September 2025)**

Wraparound hours for our 9 month- 2 year olds after funding will be charged at £6.60 per hour plus food (see below)

**2 year old funding entitlement for eligible working parents: 11 hours per week (22 hours from September 2025)**

Wraparound hours for our 2-3 year olds after funding will be charged at £6.35 per hour plus food (see below)

**3+4 year old universal and extended entitlement for eligible children: 11 hours p/w or 22 hours p/w**

Wraparound hours after funding will be charged at £6.10 per hour plus food (see below)

A condition of us receiving the funding entitlement means it is not there to cover the cost of meals, other consumables, additional hours or additional activities.

Therefore we will be making the following daily charges:  
£2.00 for breakfast, £1.50 for snack, £9.00 lunch, £5.00 for tea.

For one day per week an addition of  
£4.00 for Forest School activities, accessing woodland and farmland surrounding the nursery  
(this applies to 2, 3 + 4 year olds)

If you wish to opt out please speak to a member of the management team.

## **Standalone offer**

If you wish to access the funded sessions only with no additional services/hours then you will need to provide food for your child. This has no conditions of access, and the funded hours are free on the point of contact.

Our offer is Tuesday- Friday 8:00-13:00 or 8:00-14:00

If you need further support with the additional cost, please speak in confidence to a member of the management team.

We ask that parents provide nappies and wipes.

### **Additional funding information:**

All entitled parents need to check their eligibility through Childcare Choices on a regular basis (approximately every three months).

From September 2025 all eligible working parents will receive the extended entitlement (22 hours) the term after their child turns 9 months.

The total entitlement is either 570 hours per year, or 1140 hours if you fall within eligibility, within the current stretched offer from Buckinghamshire Council.

Fees will be paid irrespective of whether your child is present due to sickness or holiday. Discount for siblings on non-funded spaces - Full time basis 10%, part time basis 5%.
