

**STRATEGIC PARTNER GROUP (SPG) GLOBAL BUSINESS FORUM
REFERRAL AGREEMENT**

This Referral Agreement (“Agreement”) is entered into between Strategic Partner Group (“SPG”) and the undersigned Referral Partner, effective upon acceptance.

1. PURPOSE

Strategic Partner Group operates the SPG Global Business Forum, a membership-based global business community. Referral Partner may introduce prospective members to SPG in exchange for a one-time referral fee, subject to the terms of this Agreement.

2. RELATIONSHIP

This Agreement creates a non-exclusive referral relationship only. Nothing herein shall be construed as creating a partnership, joint venture, agency, employment, or fiduciary relationship. Referral Partner has no authority to bind or represent SPG.

3. SPG GLOBAL BUSINESS FORUM MEMBERSHIP

- Individual - \$399 / Annual (Entrepreneurs • Advisors • Independent Leaders)
 - Organization - \$699 / Annual (Companies • Firms • Nonprofits • Institutions)
 - Premier - \$1,599 / Annual (Customized sales & project management services)

4. QUALIFIED REFERRALS

A referral is considered Qualified only if the referred party:

- Is not an existing SPG Global Business Forum member
- Completes SPG onboarding requirements
- Pays the applicable membership fee in full
- Does not request a refund or initiate a chargeback

SPG retains sole discretion to confirm referral qualification.

5. REFERRAL FEES (ONE-TIME ONLY)

Organization	\$699	\$200
Premier (Annual)	\$1,599	\$400

- Referral fees are one-time only payment
 - No residuals, renewals, upgrades, or ongoing commissions apply

6. PAYMENT TERMS

Referral fees are paid within ten (10) business days after confirmed onboarding and successful payment. Payments are issued via an SPG-approved method. Referral Partner is solely responsible for all applicable taxes. SPG reserves the right to withhold or reverse payments in the event of fraud, misrepresentation, refund, or chargeback.

7. MARKETING & REPRESENTATION

Referral Partner may not represent SPG or the Global Business Forum as:

- **Consulting, advisory, brokerage, or investment services**
- **A guarantee of revenue, contracts, outcomes, or results**

The SPG Global Business Forum is a membership-based forum only. No guarantees are expressed or implied.

8. INTELLECTUAL PROPERTY

Referral Partner is granted limited, revocable permission to use SPG-approved names and materials solely for referral purposes during the term of this Agreement. No ownership or license rights are conveyed.

9. CONFIDENTIALITY

Referral Partner agrees to keep confidential all non-public SPG information, including member data, pricing, and internal operations.

10. TERMINATION

Either party may terminate this Agreement at any time, with or without cause. Earned referral fees for Qualified Referrals prior to termination remain payable.

11. GOVERNING LAW

This Agreement shall be governed by the laws of the State of New York. Any disputes shall be resolved through binding arbitration in New York State.
