#### POSITION ELGIBILITY LIST ANNOUNCEMENT

Firefighter / EMT-Paramedic Position Description / Duties \$36,000-\$58,000

## I. Distinguishing Features

Chiloquin Fire & Rescue (CF&R) is establishing a hiring list for the position of Firefighter / EMT-Paramedic. The Fire District Headquarters is in the City of Chiloquin and is just 28 miles north of the city of Klamath Falls. CF&R serves an area of 150 square miles (population approximately 4200) and an Ambulance Service Area of approximately 1000 square miles. CF&R was founded in 1980 and responded to an average 1,085 incidents over the last 3 years. The District works cooperatively with neighboring Fire Departments through Mutual Aid Agreements and currently employs 8 full-time employees with an average of 32 volunteer firefighters.

#### II. Qualifications

- 1. Be 18 years of age.
- 2. Minimum two (2) years of active experience as a Volunteer or Career Firefighter.
- 3. Must possess and maintain certifications/License as: NFPA Firefighter 1; Oregon EMT / AEMT / EMT-I / Paramedic; NFPA Operations Level Responder; NFPA Driver; NIMS 100, 200, 700.
- 4. Have a valid Oregon Driver License upon appointment and be insurable through the District's insurance provider.
- 5. Maintain the ability to physically accomplish the requirements of the District. To have above average mobility in claustrophobic and hazardous areas, the ability to lift and move over 50 pounds, intermittent sitting, standing, kneeling or stooping for long periods of time, able to be exposed to and function in noisy environments,
- 6. Ability to maintain composure, think clearly and interpret orders and/or directions under emergency conditions as well as in daily operations. Ability to understand and follow oral suppression / prevention materials and information.
- 7. Ability to routinely work with the general public, public employees, officials, volunteers and staff in a courteous manner.
- 8. Ability to perform a variety of mechanical operations.

#### III. Benefits

PERS, Sick Leave Accrual at 8 hours per calendar month and vacation to a maximum of 240 hours. Family Medical Leave per Oregon Employment Law.

#### **IV.** Selection Process

Application packets may be requested by contacting the Fire District Office. Interested candidates will submit a CF&R application *with a resume and all supporting documents* to: Chiloquin Fire & Rescue, Attention: Fire Chief Mike Cook, PO Box 437, Chiloquin, OR 97624.

Applications and resumes will be reviewed to determine qualifications of applicants. Successful candidates will be invited to participate in a physical agility, oral and EMS task performance-based interview. The successful candidates; will have a background check and reference checks made prior to job offer.
