## **West Texas Ranch Rodeo Media Policies**

### **1. Media Credentialing:**

- All media representatives must be pre-approved and registered before the event.
- Credentials must be worn and visible at all times during the event.
- Media passes are non-transferable and may be revoked for policy violations.

### **2. Photography & Videography:**

- Media personnel must remain in designated areas unless granted special permission by event organizers. Only the event photographer is allowed in the arena.
- Flash photography is prohibited near livestock to prevent distress.
- Any drone usage must comply with FAA regulations and be pre-approved by event organizers.

### **3. Live Streaming & Broadcasting:**

- Live streaming is only permitted with prior written approval.
- Media representatives must notify the event organizers of any live broadcasts.
- Unauthorized live feeds may result in credential revocation.

### **4. Content Usage & Restrictions:**

- All media content should accurately represent the event and respect participants and livestock.
- Commercial use of media content requires explicit approval from event organizers.
- Media representatives must credit the event when publishing photos or videos.

### **5. Interview & Press Conduct:**

- Interviews with competitors, organizers, or spectators must be conducted respectfully and with consent.
- Media must not disrupt event operations or interfere with contestants during competition.

### **6. Liability & Compliance:**

- Media representatives assume all risks associated with covering the event.
- Violation of any media policies may result in expulsion from the event and future credential restrictions.
- The event reserves the right to modify media policies at any time.
