Facility Name: June Road Pond

Address: 849 June Road

Description: The Private Stormwater Mitigation Facility consists of:

- Detention Pond
- Catch Basin
- Control Structure

Inspection Conducted: June 25, 2024

Last Inspected: May 3, 2023

General Condition: The overall condition of the stormwater mitigation facility is excellent. Addressing several issues involving repair and maintenance will bring this facility in line with the City of Bellingham's stormwater ordinance and minimize future, more expensive maintenance problems.

System Component: Detention Pond

Existing conditions: Bulrush and cat tails are filling in quickly since last years inspection; this could indicate an accumulation of sediments that could need removal in the future. Unwanted, small volunteer trees observed around the pond perimeter. Emergency overflow spillway becoming overgrown with plants. Overall appears to be in good working condition.

Maintenance needed: Recommend having sediment level accumulations on the eastern side of pond assessed to help plan for future maintenance needs. Removing cat tails/bulrush at end of the season may help prevent further spread. As a part of routine maintenance, remove volunteer trees. Continue to remove blackberry and other unwanted vegetation from inner side slopes and keep emergency overflow spillway free and clear.

System Component: Catch Basin

Existing conditions: Little to no sediment in catch basin.

Maintenance needed: None at this time, continue with routine maintenance as needed.

System Component: Control Structure

Existing conditions: Little to no sediment in control structure; appears to be in good working condition.

Maintenance needed: None at this time, continue with routine maintenance as needed.
