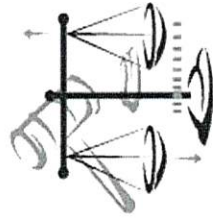


I have been charged with underage drinking...now what?

You have two options!

- Go to court and pay the fine with the possibility of loss of license and higher insurance costs.
- or
- Complete Fresh Start courses where you will:
 - Gain knowledge of high risk choices, trigger levels, guidelines, and phases of alcohol.
 - Have my citation dismissed.
 - Not have my license suspended.
 - Not have my insurance increased.



If I choose to participate in the Fresh Start Program, I must do the following:

1. Register for the Fresh Start program **within 10 days** of receiving the citation (this form, both sides).
2. Complete the online course (Cost of course is \$65)
 - Complete the 12 hour course **within 30 days**
 - Do not reoffend before, during the class time or within one year of completing the class.

How to Register

Fill out the Fresh Start registration form completely and mail it within 10 days of receiving the citation. Send a check or money order to Fresh Start with the registration form. Registration Fee: \$75 (all ages)

1. If paying the Fresh Start registration online, please include confirmation number on registration form. You may send the completed registration form by email **ONLY** if you paid online www.officalpayments.com
2. **Sign** guilty plea agreement on back of registration form.

Once this registration form is received, you will be sent an email with instructions to register for the online class.

Fill out COMPLETELY and CLEARLY; unreadable or incomplete forms will be invalid and your ticket will go to court. Mail check or money order within 10 days of receiving the citation. Send to **Fresh Start, 165 N Fourth St, Platteville, WI 53818**

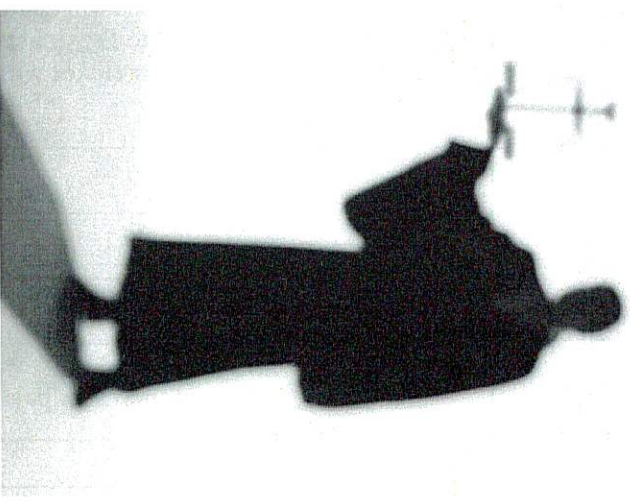

Notice:
To avoid maximum penalties of your offense, it is crucial that you read and follow the procedures in this brochure.

Fresh Start is an alcohol and drug risk program for youth 13 to 20 years of age who may be likely to engage in high risk drinking or drug use. It is a 12-hour program, completed online.

The course focuses on the risks associated with alcohol used and how to lower those risks. Thousands of youth throughout the country are taught the curriculum through juvenile justice systems, underage drinking programs and school.

Fresh Start is a program originating from the Roundtable of Grant County in conjunction with the Grant County Drug Free Coalition.

Guilty Plea Agreement

I hereby admit to the charge of consuming/possessing intoxicants. I agree to successfully complete the Fresh Start Program by:

1. Registering for **BOTH** the online course and the Fresh Start Program within 10 days of receiving my citation
2. Completing all 12 hours of course work
3. Providing Fresh Start with my certificate of successful course completion by email or mail
4. Not reoffend within one year of the course or before turning 21, whichever comes first.

If proof of successful completion is provided, this matter will be dismissed after one year if there are no other underage drinking offenses or until turning 21, whichever occurs first. I understand that if I reoffend both citations will go to court. I will be required to pay both fines and will lose my operating privileges for a length of time determined by the judge.

I, the defendant hereby consent to the above order and agree to cooperate/participate in the program. If under 17, the undersigned parent / guardian hereby consent to entry of the above order and agrees to cooperate in the program.
