# **ABOUT US**

## **Supporting Families**

We are a non-profit organisation started by a couple of local mums during the pandemic of 2020. The creation of Baby Necessities came from a motivation to help alleviate child poverty after watching a documentary on the growing need for baby banks in the UK.

Our vision was to support families during hardship, as well as see the baby items our children no longer needed, re-used to protect the environment and reduce unnecessary waste.

#### What we do

We collect good quality, pre-loved items such as clothes, toys and equipment, and distribute them to families in need across Southampton and surrounding areas. All items are cleaned and, where necessary, safety checked. We take care in the presentation of our bundles and every one of them is lovingly prepared by one of our volunteers.

#### Who we help

Access to Baby Necessities is via third-party referral by professionals such as community midwives, health visitors, GP's, family support workers, social workers, educator or teacher, food bank volunteer, religious leader etc.

We aim to meet each request with our stock of donated items and help individuals and families from all backgrounds, regardless of their personal situation, by providing their little ones (up to the age of 5 years old) with the basic supplies they need.

So far we have helped cases of financial difficulty, domestic abuse, homelessness, refugee/asylum seekers, single parents, young parents, and women who have been trafficked.

#### **Our aims**

- To help alleviate child poverty across Hampshire by providing new and good quality pre-owned items to families experiencing hardship.
- To promote recycling of second hand items in order to protect the environment and reduce unnecessary waste.
- To promote safe sleeping by providing a moses basket with a brand new mattress.

# **WELCOME**



### **Operations Manager:**

My name is Hayleigh, I am one of the Founders of Baby Necessities and I hold the role of Operations Manager within the charity. I cannot believe we are now a year old and have moved from operating out of my loft to having our own premises. This has allowed us to fully establish ourselves within the local community. Growing our trustee board and becoming a registered charity has also helped to strengthen our organisation.

Since setting up Baby Necessities we have discovered that there is a real need for this service in our local area. # **NATIONAL LOTTERY FUNDING**

June 2021 was hugely exciting for us as we got our first big funder on board. Thanks to the players of The National Lottery and The National Lottery Community Fund, we were awarded a phenomenal grant of £34,911.

This grant helped us to secure our new home at Basepoint in Romsey Abbey Park Industrial Estate, as well as creating two part time staff roles which will ensure the day to day operations of the baby bank continues to run smoothly. We use our new 'hub' to hold volunteering sessions with members of the local community, host networking meetings to grow our relationships with other charities and organisations and can offer support to the public by providing access and information on a range of local support groups.



# **OPEN DAY**

Our bake sale and open day saw the launch of our new Give a Gift campaign and helped us raise some vital funds.

On the 17th July 2021, to celebrate the move to our new premises, we held an open day and bake sale to give our supporters the chance to come and look around at where we are based and hear about what we do. We also used the opportunity to launch our new Give a Gift campaign which has been set up to provide birthday gifts and a cake to disadvantaged children. Nothing seemed more fitting than to get baking and sell cakes to help spread the word of our new project.

Thank you to the Mayor of Romsey and Caroline Noakes for stopping by and showing their support.

We also managed to raise £163 from our bake sale.







# **GIVE A GIFT**

# The launch of our new Give a Gift campaign

The aim of our new project is to give underprivileged children up to the age of 11 a gift on their birthday. Gifts are tailored to the child's interests and age and can either be pre-wrapped to help remove some of the stress of preparing for the day, or given alongside wrapping paper and sellotape for the family to wrap the gifts themselves. Our birthday bundles can also include a banner, balloons, birthday card and an optional birthday cake.







Just like with the baby bank, we take third party referrals from health professionals, charities and other organisations across Southampton and the surrounding areas. These bundles are then collected by the referrer and delivered to the family in time to celebrate the big day. So far, we have distributed a whopping **47** birthday gifts.

We hope to make all the children we help smile and give them the special day they deserve.







In August 2021 we were all devastated to hear the news of the goings on in Afghanistan and how in a heartbeat thousands had fled their homes to find refuge. As soon as we learnt of these evacuees being temporarily housed in Hampshire, we took immediate action by teaming up with Community First to collect and distribute donations of essential items which could be passed on to these families.

Our Afghanistan appeal was a huge success! And the support we received from the local community was awe-inspiring. In just two hours, the volume of donations we received meant that we were able to fill two cars and a van. It meant we were able to pass on a total of 64 packs of nappies, 37 activity packs, 32 'wardrobes in a bag', 21 shoe box parcels, 7 pushchairs, a further 32 bags full of clothing sorted into age and gender, plus blankets, toiletries, hats, scarfs, coats and much more.

It has been truly heart-warming working alongside other groups, organisations and charities, and with our incredible volunteers, to show support to the families evacuated from Afghansitan.

We continue to provide for families who are being housed in our local area through our normal referral processes.

### WALK THE TEST WAY FUNDRAISER

This year, team Baby Necessities decided to join the Romsey Rotary Club's annual fundraiser and Walk the Test Way to raise money for our charity. On

the 26th September 2021 we completed 12 miles in just over 4 hours and managed to raise a whopping £1500.

Two out of the eighteen team members completed the whole 25.5 miles! Our team were made up of staff, trustees and supporters. We want to say a big thank you to everyone who participated and who sponsored us to help make this a huge success.















What we have achieved during this past year would not have been possible without the fantastic support of our volunteers. Each and every one of them has worked tirelessly sorting through clothes, washing, ironing, putting away donations and building bundles for families. Our volunteers are given the opportunity to learn new skills, gain experience and meet like minded people. All while being a fundamental part of the Baby Necessities team ensuring the basics needs of the families we help are met.



We currently have approximately 30 volunteers on our books. Due to the impact of the pandemic, we have not been able to develop our volunteer program as much as we had hoped, so over the next year we aim to build a thriving community of volunteers and continue to be on the look out for more helping hands.

#### Statement of Public Benefit

Our service benefits children of families who, for various reasons, do not have access to the basic essentials that every child deserves. We provide bundles to our referral partners in and around Southampton. In providing our services we further benefit the public, as follows:

- ♦ **Families:** Providing the essentials helps to ensure that infants and young children have a safe place to sleep, are clean and are suitably clothed. This helps to relieve both financial pressure and emotional stress by having Baby Necessities providing the basics.
- Referral Partners: Professionals now have a service within the local community that they can reach out to when a family that they are working with are in need of basic and essential supplies.
- Wider Community: We offer a volunteering opportunity where members of the community can learn new skills and meet new people. Members of the community can also donate their pre-used items which they know will go to good use, help families in need and also have a positive impact on the environment.

Under Section 17 of the Charities Act 2011, the Trustees have given serious consideration to the Charity Commission's general guidance on public benefit when planning the charity's activities and in particular to the relief and prevention of poverty in children.

### Methods used to recruit and appoint new trustees

New Trustees are recruited by the board and in line with Baby Necessities Southampton's Trustee Recruitment Policy. Positions are advertised across our social media channels, on our website and using platforms such as Reach Volunteering. Interviews take place with a trustee and a senior member of staff. Prior to appointment, Trustees are DBS checked and are required to sign our Trustee Declaration. Newly appointed Trustees will receive a formal induction which will outline the work of the charity and a set of key documents (such as policies and the constitution), to enable them to gain the required information to fulfil their role.

Where a skills gap is identified on the board, we aim to seek Trustees suitable to fill this gap.

#### **Future Plans**

Baby Necessities plans to meet the ever increasing demands for our service. We plan to meet these demands by recruiting new members of staff and hosting more volunteer sessions over the coming years.

We also plan to further our impact in the local community by providing free training and well-being sessions for the public to access, as well as broaden our range of information on local charities and organisations to improve our signposting service.

#### **Financial Review and Reserves Policy**

Baby Necessities has had a successful first year, generating an income of over £54k (a combination of restricted and unrestricted funds) via grants, donations and fundraising activities. Our total expenditure for the year was £35, 479 and a sum of £19, 359 was carried over. Of this surplus £14, 338 is restricted, primarily in relation to National Lottery funding. Expenditure is restricted to premises and salary costs.

Donations-in-kind are not reflected in the income or expenditure within our financial statements but represent a significant additional donation stream and source of sustainability. During the new financial year the tracking of the value of these has commenced.

The Trustees agree that Baby Necessities should hold a minimum sum of £5,000 in unrestricted reserves. This is to ensure rent, utilities and wages can be funded for 1 month. A reserves policy will be put in place and the trustees are mindful of the requirement to build up this reserve amount. We endeavor to hold a sum of 4 months worth of running costs in reserve.

The board is satisfied about the charity's ability to continue operating.
