#### **GENERAL RULES**

A. This Flower Show conforms to the standards established by National Garden Clubs, Inc. (NGC). *The Handbook for Flower Shows (HB) 2017 Edition*, with revisions posted on the NGC website, is the authority for all issues not covered by the schedule, which is the Law of the Show. The *Revised Digital Handbook for Flower Shows 2017 Edition* can be downloaded for free from NGC website: gardenclub.org. It can be found under the tab for "Schools" – "Flower Show Schools" – "Flower Show School Resources" or you can reach it via this link:

Put your cursor over the link and use Ctrl + Click or some may only need to Click to go to the website referenced. You may reach other references listed in the schedule by using this same technique.

- B. 1. Competition in the Design, Botanical Arts, and Education Divisions is open to exhibitors who are members of Florida Federation of Garden Clubs, Inc. (FFGC). Competition in the Horticulture Division is open to all exhibitors in Florida.
  - 2. All entries must be pre-registered with the appropriate Entries Chairs. See specific registration deadlines listed in the Rules for each Division. Refer to Committee Chairs directory on p. 3 of this Schedule. Registration forms are available online on the Manatee River Garden Club (MRGC) website: www.manateerivergardenclub.com Flower Show page and at the club.
  - 3. Refer to each Division's Rules for times entries can be placed.
  - 4. All exhibits MUST be removed from MRGC on Saturday, April 5, 2025, between 4:00pm and 6:00pm. Any items not removed by 6:00pm will be disposed of without notice.
  - 5. Judging will begin at 10:00 am on Friday, April 4, 2025.
- C. Complete procedure for making entries is stated in each Division's Rules. See Entry Tag and Entry Card information in the Rules for each specific Division.
- D. The Classification Chairman for each Division checks exhibits for conformity to the schedule prior to judging. Final determination for conformance is the judges' responsibility.
- E. The General Chair and the Classification Chairs for each Division are available during judging for possible consultation. They, along with the judges and clerks, are the only personnel allowed on the floor during judging.
- F. The decisions of the judges are final. Awards may be withheld if not merited.
- G. There must be an emphasis on fresh plant material; no artificial plant material is permitted in any exhibit in any Division.
- H. Each exhibitor is limited to one entry per class, except in the Horticulture Division and the Botanical Arts Horticulture Section if each is a different species, variety, cultivar, type or color.
- I. Manatee River Garden Club, Inc. will strive to assure the safety of all items after arrival and placement but, is not responsible for loss or damage to exhibits.
- J. Native plants may be entered provided such plants have been legally obtained and grown by the exhibitor for at least 90 days. Reference: https://edis.ifas.ufl.edu/publication/EP297
- K. The use of plant material classified as Federal Noxious is prohibited. Reference: Reference: weedlist.pdf (usda.gov)
- L. The use of plant material on Florida's Federally Listed Plant as Endangered or Threatened is prohibited. Reference: Florida's Federally Listed Plant Species / Florida Statewide Endangered and Threatened Plant Conservation Program / Forest Health / Our Forests / Forest & Wildfire / Home Florida Department of Agriculture & Consumer Services (fdacs.gov)

#### **AWARDS**

The NGC standard system of awarding is used in all divisions:

- 1. Only one (1) first-place (blue) ribbon per class or subclass; must score 90 points or more.
- 2. Only one (1) second-place (red) ribbon per class or subclass; must score 85 points or more.
- 3. Only one (1) third-place (yellow) ribbon per class or subclass; must score 80 points or more.
- 4. One (1) or more honorable mention (white) ribbons as merited; must score 75 points or more.

### NGC Top Exhibitor Awards offered in this flower show

#### Division I – Design

One Designer's Choice Award may be offered to the highest scoring blue ribbon winning exhibit scoring 95 or more in Section A. The Section must have a minimum of three (3) classes with a minimum of four (4) entries in each class. A rosette of purple ribbons. Handbook chapter 5.

**One Table Artistry Award** may be offered to the highest scoring blue ribbon winning exhibit scoring 95 or more in Section B. The Section must have a minimum of three (3) classes with a minimum of four (4) entries in each class. A small rosette of blue and white ribbons. Handbook chapter 5.

One Award of Design Excellence may be offered to the highest scoring blue ribbon winning exhibit scoring 95 or more in the entire Design Division entered by an individual. There must be at least two (2) Sections of Designs with a minimum of three (3) classes per Section. Each class must have a minimum of four (4) entries. A rosette of gold ribbons. Handbook chapter 5.

#### Division II – Horticulture

**Two (2) Awards of Merit** may be offered – one each in Sections A and B. The Award of Merit is offered to the highest scoring blue ribbon winning exhibit scoring 95 or more in each Section entered by an individual. There must be at least three (3) classes listed in the Schedule for each eligible Section, but no minimum number of exhibits per class. A rosette of orange ribbons. Handbook chapter 5.

Seven (7) Grower's Choice Awards may be offered – one each in Sections C, D, E, F, G, H, and J. The Grower's Choice Award is offered to the highest scoring blue ribbon winning exhibit scoring 95 or more in each Section entered by an individual. There must be at least three (3) classes listed in the Schedule for each eligible Section, but no minimum number of exhibits per class. A rosette of dark green ribbons. Handbook chapter 5.

**Two (2) Arboreal Awards** may be offered – one each in Sections I and J. The Arboreal Award is offered to the highest scoring blue ribbon winning exhibit scoring 95 or more in each Section entered by an individual. There must be at least three (3) classes listed in the Schedule for each eligible Section, but no minimum number of exhibits per class. A rosette of green ribbons. Handbook chapter 5.

**One Award of Horticultural Excellence** may be offered to the highest scoring blue ribbon winning exhibit scoring 95 or more in the entire Horticulture Division entered by an individual. There must be at least two (2) Sections of Horticulture. There is no minimum number of exhibits required per class. A rosette of green, blue, and orange ribbons. Handbook chapter 5.

#### **Division III – Education**

**One Educational Award** may be offered to the highest scoring blue ribbon winning exhibit scoring 95 or more in the Education Division. A minimum of two educational exhibits designated as eligible must be present. The work may be of an individual or organization. A rosette of brown and white ribbons. Handbook chapter 5.

#### **Division IV- Botanical Arts**

Section A. Photography

One Botanical Arts Photography Award may be offered to the highest scoring blue ribbon winning exhibit scoring 95 or more in the entire Botanical Arts Photography section entered by an individual. There must be at least three classes with a minimum of four exhibits in each class. The photograph must relate to NGC goals and objectives. A rosette of black and white ribbons. Handbook chapter 5. Section B. Artistic Crafts

**One Artistic Crafts Award** may be offered to the highest scoring blue ribbon winning exhibit scoring 95 or more in the entire Artistic Crafts section entered by an individual. The exhibit must contain some plant material. There must be at least three classes in the Section with a minimum of four exhibits in each class. A rosette of navy blue ribbons. Handbook chapter 5.

Floralia 16 Design Award is offered to exhibit winning the NGC Award of Design Excellence.

# DIVISION I – DESIGN "WATER COLORS" DESIGN DIVISION RULES

- A. The NGC exhibit policies are printed in the *Handbook for Flower Shows*, Chapter 7, exhibiting in the design division, NGC policies and guidelines.
- B. Advance registration with the Design Entries Chair is required by March 15, 2025. Registration forms are available on the MRGC website or at the club.
- C. Plant material and non-plant material permitted and not permitted in the Design Division are printed in the Handbook for Flower Shows, Chapter 7.
- D. All plant material used in the design must be identified on a 3" x 5" white card to be provided by the exhibitor and included with the entry card.
- E. The exhibitor is required to conform to the stated descriptions and limitations of the design type if named in the class.
- F. Rules for design types, advanced design types, table designs, and table appointments are printed in the *Handbook for Flower Shows*, Chapter 7.
- G. Designer is on his/her honor that the design being entered has not been previously entered or judged in an NGC Standard Flower Show.
- H. The Scale of Points for Design is located in Chapter 14 of the Handbook for Flower Shows and is printed below.
- I. Each class is limited to four (4) entries. Exhibitor may enter multiple classes in the Design Division, but only one exhibit per class.
- J. Entries Chair will prepare pre-printed entry cards for exhibits. Entry card will be located at the exhibit placement site. Exhibitor must check entry card for accuracy.
- K. Entry must be the work of one individual whose name will appear on the entry card.
- L. Designs will be placed on Thursday, April 3, 2025, from 9am until 6pm.
- M. The Classification Chair will check each entry for conformance before designer leaves the placement area.
- N. If the designer is unable to fulfill the assignment, it is the designer's responsibility to find a replacement.
- O. If the designer is unable to transport and/or set up the design, a substitute may enter the completed design for the designer.

# DIVISION I – DESIGN "WATER COLORS" SECTIONS AND CLASSES

### SECTION A - "WHERE SUNSHINE MEETS THE SEA"

Designs eligible for Designer's Choice Award. Plant material may be dried, treated dried, and/or fresh. Exhibitor has freedom to choose other components within NGC policies.

### CLASS 1. "SUNSHINE SKYWAY BRIDGE"

An Angular Design to be staged using a black pedestal measuring 20" X 20" on top and which is 38" tall. Pedestals will be placed in front of a cream colored wall.

#### CLASS 2. "THE GREEN FLASH"

A Reflective Design to be staged using a black pedestal measuring 20" X 20" on top and which is 38" tall. Pedestals will be in front of black fabric panels.

#### CLASS 3. "FLAMINGO FLAMBOYANCE"

A Creative Line-Mass Design to be staged using a natural colored wood pedestal measuring 20" X 20" on top and which is 38" tall. Pedestals will be in front of black fabric panels.

#### SECTION B - "FRESH FROM FLORIDA"

Designs eligible for the Table Artistry Award.

#### CLASS 4. "FORKS & CORKS - AN ELEGANT DINNER"


An Exhibition Table staged on a black pedestal measuring 20" X 20" on top and which is 38" tall. Pedestals will be placed in front of natural colored wood doors.

#### CLASS 5. "START YOUR DAY WITH A GLASS OF OJ"

A Functional Breakfast Table for Two staged on a 28" round table. Table is covered to the floor with a white tablecloth. Designer may supply an additional overlay.

#### CLASS 6. "STONE CRABS, GROUPER, AND SHRIMP - OH MY! -LUNCH AT THE DOCKS"

An Exhibition Table using a black frame to be supplied by staging committee. Diagram and measurements of frame are:



# **SECTION C - "IT'S SPRINGS TIME"**

This class is a Companion Class – two individuals (one novice and one advanced designer) work together to create one design. Designs are eligible for ribbons, but not for an NGC Top Exhibitor Award. Consultant/Entries: Lori Richie, 941-713-4884 loririchie@cs.com

### CLASS 7. "TUBING ON THE ICHETUCKEE"

A Tubular Design to be staged on a natural colored wood pedestal measuring 24" X 24" on top and which is 38" tall. Pedestals will be placed in front of a cream colored wall.

# DIVISION II – HORTICULTURE "EARTH TONES"

#### HORTICULTURE RULES

- A. The NGC exhibit policies are printed in the *Handbook for Flower Shows*, Chapter 6, Exhibiting in the Horticulture Division.
- B. The rules for a single species cut or container-grown specimens are listed in *Handbook for Flower Shows* or its supplement, *Horticulture Exhibiting and Judging*.
- C. In order to receive an NGC Top Exhibitor Award, the exhibitor must identify his/her entry by its binomial name or currently accepted scientific designation (consult *Handbook for Flower Shows*, Exhibiting in the Horticulture Division, Chapter 6).
- D. **Advance registration of entries is required**. Entry forms are to be filled out and sent to Entries Chairman by Friday, March 21, 2025.
- E. Entry cards will be completed (in pencil) by the Entry Chair/Committee. When exhibitor brings entries, she/he will check all spelling and initial the card if information is correct.
- F. Cut specimens should not have foliage below the water line, except for *Gladiolus*.
- G. If a plant is considered a flowering plant, it should be exhibited as a flowering specimen. Foliage plants may flower but, should be exhibited as foliage plants if they are grown for their leaves.
- H. Specimens with a class designation in the schedule may not be entered in the 'Any other worthy' class.
- I. The Horticulture Classification Committee Chairman and/or General Show Chairman are free to subdivide classes by color, form, size, cultivar, variety or other distinguishing characteristics."
- J. The Scales of Points for Horticulture are located in Chapter 14 of the *Handbook for Flower Shows*.
- K. Containers for cut specimens will be supplied by the committee. Wedging is allowed using cellophane wrap supplied by committee.
- L. Specimens may be double-potted. Inner container should not be visible.
- M. Exhibitor may enter more than one entry per class but NOT of the same variety, cultivar, type, size, or color unless stated otherwise in the schedule.
- N. All entries must be fresh and of superior quality, clean, and well groomed. All entries must be grown by the exhibitor. Containers must be clean and appropriate to the plant. Unless specified differently under individual Sections of the Schedule, containers are not to exceed 12" in any direction as measured across the top of the container.
- O. Plant material must be in its natural state and may not have been altered by application (treatment) of oil, commercial "shine" products, etc., that change the natural appearance. No wiring of specimens is permitted.
- P. All plant material must have been in the possession of the exhibitor the appropriate number of days: **Combination Plantings:** 6 weeks

**Annuals:** 90 days with the exception for forced bulbs such as amaryllis for which there is no minimum

**Houseplants:** 90 days

Perennials: (Herbaceous) 90 days

Arboreals (woody ornamentals): 6 months

- Q. Exhibitors are limited to no more than two entries per section with a maximum of ten (10) entries per exhibitor.
- R. All Container grown entries must be delivered to Manatee River Garden Club on Wednesday, April 2, 2025, between 9:00 am and 3:00 pm. Cut specimens may also be delivered on Wednesday, April 2, 2025, between 9:00 am and 3:00 pm. In addition, ONLY CUT SPECIMENS may be delivered on Thursday, April 3, 2025, between 9:00 am and 10:00 am. If necessary, exhibitor may replace a wilted cut specimen on Friday, April 4, 2025, between 8:00 am and 9:00 am.

- S. All entries will be checked by the Classification Committee before placement and before exhibitor leaves the placement area. The Classification Chair may disqualify any entry that does not conform to the Schedule or that is of inferior quality. The decision of the Classification Chair is final.
- T. After approval by the Classification Chair, the exhibit will be placed by the Placement Committee, unless stated differently in the Schedule.

# Section K: Washington Oaks Gardens State Park – Palm Coast Combination Plantings *HB p. 59*

A grouping of three (3) or more botanically different plants with similar cultural requirements such as light, water, and humidity. Natural accessories permitted in all Combination Plantings but must be in scale with plantings and container, and theme appropriate to the plants. Include a "map" or "drawing" indicating where each plant is located.

### Eligible for one (1) Grower's Choice Award

No container is to exceed 16" in any direction when measured across the top of the container.

Class 76 "Color Splash" Planter – a grouping of plants that emphasize the diversity of colors in plants.

Class 77 Herb Planter – a grouping of herbs in an indoor or outdoor container.

Plants can be foliage, flowering, or a combination of foliage and flowering.

Class 78 Succulent Planter – a grouping of succulent plants in an appropriate container.

# DIVISION III – EDUCATION "SAY IT WITH COLOR" EDUCATION RULES

- A. Educational exhibits may be the work of more than one individual or organization unless a Student Judge, or an Accredited Judge is seeking exhibiting credit for preparing an educational exhibit.
- B. An exhibit must occupy a minimum of eighteen (18) square feet of surface area).
- C. Scale of points for Educational Exhibits is listed in the Handbook for Flower Shows, Chapter 14.
- D. Exhibits are competitive.

# DIVISION IV - BOTANICAL ARTS "FULL SPECTRUM"

#### **BOTANICAL ARTS RULES**

- A. All Botanical Arts Horticulture, Design and Artistic Craft exhibits must contain some plant material.
- B. No artificial plant material is permitted in any exhibit.
- C. The Scale of Points for judging Botanical Arts Horticulture, Design, Artistic Crafts and Photography are listed in Chapter 14 of the *Handbook for Flower Shows* and on this page.
- D. The rules for Botanical Arts Horticulture are printed in the *Handbook for Flower Shows*, Chapter 10.
- E. The general guidelines for all Designs as printed in Chapter 7 of *Handbook for Flower Shows*, including a card provided by the exhibitor listing plant material used in the design apply to Botanical Arts Design.
- F. The rules for Botanical Arts Artistic Crafts are printed in the *Handbook for Flower Shows*, Chapter 10.
- G. The rules for Botanical Arts Photography are printed in the *Handbook for Flower Shows*, Chapter 10.

#### SECTION A. PHOTOGRAPHY - RULES

- A. All exhibits are intended to stimulate garden or gardening interest and photographic abilities and NGC objectives.
- B. Competition in the Photography Section is open to all amateur exhibitors.
- C. All exhibits must be pre-registered and completed forms must be sent to Cathy Willard, 941-524-6530 BCCWillard@aol.com.
  REGISTRATION DEADLINE: Friday, March 14, 2025.
- D. Each class is limited to four (4) entries.
- E. An exhibitor may enter as many classes as desired, but is limited to only one exhibit per class.
- F. All photographs will be judged by a three (3) person panel comprised of photography professionals.
- G. An entry must be a color photo (no collage), mounted on a mat or foam core board of any color and larger than the photo to allow a two inch border on all sides. No frames or glass permitted.
- H. In all classes, it is the exhibitor's choice of portrait or landscape orientation. Exhibitor must indicate the top of the image by writing "TOP" on the back of the corresponding area on the back of the mat or core board.
- I. Images will be displayed vertically at eye level staged on cream colored panel for judging.
- J. The size of photo can range anywhere between 5" by 5" up to 11" by 14".
- K. The photograph may be enhanced to include in-camera changes and post-production changes, to include cropping, filters, adjustments and/or darkroom techniques.
- L. Exhibitors are encouraged to identify photographed plant material, preferably with current scientific designation. This information should be provided on the registration form and the back of the mat or core board attached to the photograph.
- M. Entries to be delivered to Manatee River Garden Club on Wednesday, March 28, 2025.
- N. Exhibits are eligible for Botanical Arts Photography Award offered to the highest scoring blue ribbon winning exhibit scoring 95 or more in the entire Botanical Arts Photography section entered by an individual.
