Notes from GAPOA Regular Meeting July 10, 2021

After the minutes from the previous regular meeting meeting (May 15, 2021) were ratified, the budget was presented. Due to the dam certification an unexpected expenditure arose. Budget for the 2022 fiscal year was presented and approved.

Road maintenance is never off the agenda! Culvert replacements as required are in progress. Two road signs for current unnamed historic GA roads is being investigated with the County.

Dr. Mike Casteel, water quality specialist, continues to monitor the lake quality. He said it is important to rinse with fresh water after lake use – this includes water crafts, fishing gear, and pets! The showers will be reinstalled at the bath house. Due to the lifting of Covid-19 restrictions, the (extra) cleaning contract for the bathhouse has now been cancelled. The play scape can now be used again too. Once ratified at the next regular meeting, the minutes will be uploaded to the website. Contact any present board member with inquiries.
