Although at times the lake looks frozen solid from edge to edge, it will **NEVER** be frozen enough for anyone, including animals, to walk on! Underground springs that feed the lake, keep the lake water from freezing hard.

Potential snow and ice accumulations for the upcoming winter months, and traveling difficulties, now is the time to get prepared for such events:

- have a flashlight and spare batteries at hand
- enough drinking water for three days
- food that doesn't require cooking or heating
- alternative heating
- food and shelter for your pets
- prescription medications filled
- contact numbers of neighbors, friends, and family available
- make sure your electronic devices are charged while there is power
- blankets and extra warm clothes like hats, gloves, and jackets.

The easiest way to answer this question is to do the math! The air temperature **AND** the lake water temperature need to be 100 (or higher) when added together. Anything under 50F is **dangerous**,

even in a wet suit!

This number is the same for your dogs too - even if they tell you otherwise!

As we head into the winter months, the roads will show signs of deterioration. The freeze-and-thaw effect starts with soft spots in the road. Potholes will occur.

# Consider adjusting your travel time to allow for safer traveling!

# Assessment Notice Reminder

Assessment notices will be mailed to property owners in early February 2023

### Assessment is \$218.00

### The due date is March 15, 2023

Assessments fund ordinary maintenance expenses of roads, common areas, organizational functions, and the Property Manager's contract.

A late fee of \$35.00 will be assessed for payments received sixty (60) days after the due date and liens will be filed on any property for which assessments and late fees are not paid. Members of Greene Acres who have not paid their assessments will not be allowed access to any common property, nor will their renters or guests, even if they are the guest of an owner in good standing.



### GAPOA Regular Board Meeting Roundup November 19, 2022

Chair Fred Turck welcomed the meeting attendees and explained the process for the phone-in meeting.

The minutes from the previous regular meeting on July 16, 2022, were read and accepted.

Treasurer Debbie Turck was pleased to report the finances were on track for the first 6 months of the fiscal year. The budget is posted on the website before a meeting, and copies are available on request.

Roads and Environmental Chair, Brian Snyder reported it was the 'season of potholes'.- so please be patient. Thank you to Property Manager Wesley Baugher for the extra work with the roads. An updated long-term road plan is available on the website.

A member raised concerns about a fully laden truck using the Turkey Ridge/Top Ridge roads as a turning circle, and damaging GAPOA roads. Brian investigated and determined no signs of damage and explained there is no posted weight limit for either road. Even though GAPOA roads are 'private', they are open to public use.

Safety and Services Chair Kaci Cobb reported Beam internet provider will cease in GA end of November. Discussion took place over the need for internet at the lake. Kaci will check for hot-spot providers while we wait for Firefly to be available ('some time') in 2023.

Lake Water Quality Manager Dr. Mike Casteel and Fred gave a brief report on the lake quality, testing and monitoring, especially for quantitative results of blue/green algae during the summer months. GAPOA is in negotiations with a VA-certified company that supplies grass carp – infertile grass carp help the lake water quality.

The Activities Committee reported they are planning a spring event, so keep checking back for details in the new year!

The Welcoming Committee reported 18 welcome packs delivered to new homeowners since March 2022.

Trish McGuire (GAPOA Greeter) is looking at updating the fridge magnet for the welcome packs.

Updates from the old business including dam certification were reviewed before the regular meeting recessed to allow the board to move into the Executive Session.

The meeting adjourned at 12:48 PM.

# Keep the home fires burning - safely!

The Department of Forestry offers these safety tips:


- Store ashes in a metal container with a metal lid.
- Douse the ashes with water and place the lid on the container
- Leave ashes in the container for several days before disposing of them
- DO NOT store your metal ash container on your deck, in your garage, or in any location that may allow heat to transfer from those hot coals to nearby flammable items.
- DO NOT place hot ashes in a dumpster or trash can
- DO NOT dispose of ashes in paper, plastic, or cardboard containers
- DO NOT assume the ashes are cold and pour them onto your garden or tree line
- Once you are POSITIVE your container of ashes is "cold," place it in a pile away from anything else

# Wood Stove and Fireplace Safety there are **three** essentials:

- have your chimney cleaned each season
- only burn seasoned firewood do not burn plastic material or treated wood
- burning at high heat reduces build-up of creosote in the chimney which can cause chimney fires

## If You Experience a Chimney Fire CALL 911

Do not try to extinguish it yourself. Ensure everyone is counted for, and exit the building to your designated safe meeting area
