

2024 Suncoast Quilt Expo – Consignment Shop Want to earn some extra cash? Cash you could use to enlarge your stash. Consider our Consignment Shop at our quilt show. If you have quilts, home deco items, or wearables that you wish to sell, we will have a booth set aside to help you. Forms will be available online and at the October meeting. Each item will require a separate, completed form. If you have multiple of an item for the same price you may indicate on your form how many you have and submit one form for all the items.

Please complete the entry forms and return one copy (the second copy should be submitted at the time you drop off your items for the consignment sale). to June Cannon, by mail (11846 Dunster Ln, Parrish, FL 34219), email (June.cannon@sbcglobal.net).

Items MUST be clean and odor free. A 20% consignment fee will be deducted from the proceeds and the funds will be earmarked for the 2024 quilt show. For items being judged that you wish to sell, a "For Sale" tag will be affixed to the quilt directing interested parties to the Consignment Shop attendant for upcoming meetings.

We will collect the items on the same day and time and place that the quilt show quilts are dropped off or on November 14th during the quilt show set-up. A consignment form will also be required in addition to the entry form for any judged items.

We will accept consignment any items that are handmade, as our members have additional skills. So, check your closets for any quilts, place mats, table runners, potholders, or quilted jackets you'd like to turn into \$\$\$.

- Unsold items must be picked up at the United Harvest Methodist Church on Saturday, November 16th, between the hours of 4:00 p.m. and 5:00 p.m. Either the consignor or an authorized alternate must collect the unsold item. - Items being judged in the quilt show are also available for consignment. A tag will be affixed to the item directing the prospective purchaser to contact the Consignment Shop attendant for further information. Consignment entry forms must also be completed for these items.
