Cully retains the right to deny, revoke or limit any permit at any time, for misrepresentation of permit information.

The Permittee and every member of the permittee's party or family, whether they have signed the permit or not, understand and accept the risks and release and agree to hold harmless, indemnify and defend Cully and all Cully subsidiaries and their officers, directors, employees and agents from any and all liability and costs of any kind whatsoever with respect to this permit and the use of Cully lands.
