The United States Constitution

Article II, Section 1 of the U.S. Constitution imposes only three eligibility requirements on persons serving as president, based on the officeholder's age, time of residency in the U.S., and citizenship status:

What Is the Constitution?

"No person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President; neither shall any person be eligible to that Office who shall not have attained to the Age of thirty-five Years, and been fourteen Years a Resident within the United States."

Property Taxes and Insurance: One-Time Payment Concept

- **One-Time Property Tax Payment:** Homeowners make a single payment to cover property taxes for the lifetime of homeownership, managed through a publicly controlled trust fund.

- **Fair Wage for Trucking:** Include trucking in the Fair Wage Act, with mandatory overtime and stricter regulations for freight brokers.

Shared Cost Childcare Model

- **Presidential Directive:** Use Executive Orders to initiate shared childcare models in federal programs and incentivize public-private partnerships for broader adoption.
