Automatic Criminal Record Exoneration Act

"To provide a healthy democracy that includes all and to allow a new study of recidivism by this Act. This Act is intended to limit the high crime rate we see in the news by repeat offenders"

It is expected that 100 million + people with records and non-records will support this Act

6.	(a) "Criminal Record" A criminal record, police record, or colloquially RAP sheet is a
	record of a person's criminal history and non-convicted records. Federally, state, and local
	Government and any non-government repository.
7.	SECTION.3.
8.	This Act will automatically exonerate criminal records in all record repositories at the end of three
	years of completion of sentencing terms, regardless of being on probation or not. Restitution can
	be sued in civil court.
9.	This Act will require Court Records to seal all records after three years of conviction.
10.	This Act will not affect any laws regarding sexual offender registration, meaning that if you are a
	sexual offender you must comply with the laws regarding registration.
11.	This Act will make criminal background checks prohibited for all public and nonpublic housing.

12.	This Act will make criminal background checks prohibited for Small Business Administration,
	Banks, and private and non-private business loans.
13.	This Act will require Department of Housing and Urban Development (HUD), Fair Housing Act,
	and Small Business Administration (SBA) to create policies that background checks are
	prohibited.
14.	This Act will make it a Federal Crime Code if any entity holds citizens and non-citizen criminal
	and traffic records to be used pursuant to employment or housing purposes.
15.	SECTION.4.
16.	This Act will NOT require appropriations to delete/cancel/exonerate records in the FBI NCIC,
	other databases that hold citizen records, and for Court to seal records. At the time of making this
	bill law, the Federal Bureau of Investigation can enforce, provide oversight, and investigate all
	noncompliance and manipulations.

17. **SECTION.5**.

- 18. The Federal Bureau of Investigation can charge the Board Members of the Corporations that will refuse to comply.
- 19. This Act shall be enacted as approved by Congress.
