The United States Constitution

Article II, Section 1 of the U.S. Constitution imposes only three eligibility requirements on persons serving as president, based on the officeholder's age, time of residency in the U.S., and citizenship status:

U.S. Constitution - Presidential Candidate Eligibility

"No person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President; neither shall any person be eligible to that Office who shall not have attained to the Age of thirty-five Years, and been fourteen Years a Resident within the United States."

Objective

- Penalize companies complicit in forced labor or exploitation, building on existing models like the EU Anti-Trafficking Directive.

4. Strengthen Domestic Policies:

 Pass U.S. legislation to ensure fair labor practices, protect migrant workers, and address disparities in justice and education systems. Align domestic efforts with international standards.

5. Citizen Reporting Systems:

 Establish systems where individuals can report human rights violations anonymously, supported by international monitoring bodies.
