

**The United States Constitution** 

Article II, Section 1 of the U.S. Constitution imposes only three eligibility requirements on persons serving as president, based on the officeholder's age, time of residency in the U.S., and citizenship status: U.S. Constitution - Presidential Candidate Eligibility

"No person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President; neither shall any person be eligible to that Office who shall not have attained to the Age of thirty-five Years, and been fourteen Years a Resident within the United States."

### Legislation Proposal: The Ukraine Aid Accountability and Reform Act

- Establish a public **Online Aid Portal** to track all U.S. aid to Ukraine in real time.

- Redirect aid to trusted NGOs if benchmarks are not met.

#### **Executive Order for Immediate Action**

In addition to legislative efforts, Cordova has outlined an **Executive Order** plan to be enacted upon assuming office. This Executive Order will:

- Mandate the creation of an aid tracking system within 180 days.
- Implement independent audits and quarterly reporting on aid expenditures.
- Establish a time-limited framework for aid tied to demonstrable reform milestones.
