The United States Constitution

Article II, Section 1 of the U.S. Constitution imposes only three eligibility requirements on persons serving as president, based on the officeholder's age, time of residency in the U.S., and citizenship status:

U.S. Constitution - Presidential Candidate Eligibility

"No person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President; neither shall any person be eligible to that Office who shall not have attained to the Age of thirty-five Years, and been fourteen Years a Resident within the United States."

"Journalists are the voice of the people, and their courage must be protected," said Vincent Cordova. "We must ensure that threats against truth-tellers are met with action, not silence. At the same time, we will fiercely safeguard public privacy and stop any attempt at government overreach."

Key Provisions of the Updated Executive Order

1. Journalists as Guardians of Public Awareness

- Journalists will play a **leading role** in identifying harmful online activities, including:
 - True threats** of violence against individuals.
 - Doxxing**: Malicious sharing of private information.
 - Incitement of violence** targeting journalists and others.
- Verified reports of such activities will be submitted to designated federal agencies for **narrow, targeted action**.

2. Federal Safeguards Against Overreach

- Federal agencies, including the **DOJ** and **DHS**, may act **only on verified reports** submitted by journalists or independent sources.
- Mass surveillance** of the internet and public communications is strictly prohibited.

3. Independent Oversight and Transparency

- An **Independent Oversight Committee**, composed of journalists, legal experts, and public representatives, will:
 - Review federal actions for compliance with constitutional protections.
 - Publish **annual public transparency reports** on investigations and privacy safeguards.

4. No Mass Surveillance

- All actions under this order must adhere to the **First Amendment** (freedom of speech) and **Fourth Amendment** (protection from unreasonable searches).

5. Support for Journalists

- Journalists reporting harmful conduct will receive **anti-reprisal protections**, ensuring they can report freely and without fear of retaliation.
