The United States Constitution

Article II, Section 1 of the U.S. Constitution imposes only three eligibility requirements on persons serving as president, based on the officeholder's age, time of residency in the U.S., and citizenship status:

U.S. Constitution - Presidential Candidate Eligibility

"No person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President; neither shall any person be eligible to that Office who shall not have attained to the Age of thirty-five Years, and been fourteen Years a Resident within the United States."

Why Campaign Finance Reform Is a National Security and Democratic Necessity

Cordova emphasized that the current campaign finance system poses clear and present dangers to the nation's security, sovereignty, and democratic integrity. Transitioning to government-funded campaigns is the most effective way to eliminate these threats, ensuring elections reflect the will of the people rather than the interests of a privileged few. By removing private wealth and dark money from the equation, we can create a fair and transparent system that protects the sanctity of our democracy.

- **Foreign Influence:** Adversaries like Russia and China have been documented using financial channels, disinformation campaigns, and covert funding to manipulate U.S. elections. Allowing unregulated contributions creates direct pathways for these threats.
- Critical Infrastructure Vulnerabilities: The U.S. Department of Homeland Security recognizes elections as critical infrastructure. Any compromise to this system—financial or otherwise—weakens the nation's resilience.
- **Erosion of Public Trust:** When foreign money and dark money dominate campaigns, voters lose faith in the democratic process, creating division and instability that adversaries exploit.

Key Provisions of Cordova's Executive Order: Transitioning to Government-Funded Campaigns

If elected, Cordova's Executive Order will:

- 1. **Mandate Real-Time Disclosure of Campaign Contributions:** Require all campaigns and Political Action Committees (PACs) to disclose contributions within 24 hours of receipt, enabling voters to know who is funding their leaders in real time.
- 2. **Establish a National Security Task Force for Electoral Integrity:** Form a coalition of experts from the Department of Homeland Security, Federal Bureau of Investigation, and intelligence agencies to monitor, investigate, and counter foreign interference in campaign financing.
- 3. **Enhance Cybersecurity for Campaigns:** Direct funding to campaigns for implementing secure systems to prevent hacking and tampering with financial data and donor information.
- 4. **Ban Foreign Contributions:** Enforce stringent penalties for accepting or funneling money from foreign entities, ensuring zero tolerance for violations.

- 5. **Transition to Government-Funded Campaigns:** Federal elections will be funded entirely through a dedicated public fund, ensuring equal resources for all qualified candidates. This model will be financed by closing tax loopholes, implementing a small levy on high-frequency trading transactions, and redirecting penalties from campaign finance violations.
- 6. **Prohibit Dark Money Channels:** Close legal loopholes that allow nonprofits and shell companies to disguise political contributions.

Framing Campaign Finance as National Security

Cordova's approach builds on historical precedents, such as Executive Order 13848 (2018), which declared foreign election interference a national emergency. His proposed EO leverages the President's constitutional authority to safeguard the nation from threats to its democratic institutions.

"Election integrity is not just about politics; it's about preserving the soul of our nation," said Cordova. "When foreign actors manipulate our elections, they're not just targeting candidates—they're targeting our way of life."
