The United States Constitution

Article II, Section 1 of the U.S. Constitution imposes only three eligibility requirements on persons serving as president, based on the officeholder's age, time of residency in the U.S., and citizenship status:

U.S. Constitution - Presidential Candidate Eligibility

"No person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President; neither shall any person be eligible to that Office who shall not have attained to the Age of thirty-five Years, and been fourteen Years a Resident within the United States."

Executive Order on the Task Force for Clean and Quality Food Standards (CQS Task Force)

By the authority vested in me as President by the Constitution and the laws of the United States of America, it is hereby ordered as follows:

Section 1: Purpose

The health and well-being of the American people are of utmost importance. The widespread use of artificial chemicals, preservatives, and genetically modified ingredients in fast food and restaurant meals has contributed to rising health issues, including obesity, cardiovascular diseases, and other chronic conditions. To ensure that all food served in fast food chains and restaurants meets the highest quality standards, this Executive Order establishes the Task Force for Clean and Quality Food Standards (CQS Task Force) to implement a transition to chemical-free, Quality A foods within one year.

Section 2: Establishment of the CQS Task Force

- (a) There is hereby established the Task Force for Clean and Quality Food Standards (CQS Task Force), which shall be responsible for overseeing the transition to Quality A food standards across all fast food and restaurant establishments nationwide.
- (b) The CQS Task Force shall consist of:
 - Public health experts
 - Agricultural scientists
 - Supply chain analysts
 - Economic advisors
 - Restaurant industry representatives
 - Consumer advocates
 - Legislative and policy experts

- Technology and data analysts
- Any additional specialists deemed necessary by the CQS Task Force to achieve its mandate
- (c) The Secretary of Health and Human Services, in coordination with the Secretary of Agriculture and the Commissioner of the Food and Drug Administration, shall appoint members to the Task Force within 30 days of this order's enactment.

Section 3: Duties and Responsibilities

- (a) The CQS Task Force shall collect and analyze data on:
 - The current levels of artificial chemicals and preservatives used in food service
 - The availability of organic, chemical-free ingredients in the supply chain
 - The potential health benefits of transitioning to Quality A food
 - The economic impact on restaurants, farmers, and consumers
- (b) The Task Force shall develop the **National Food Quality Report** within 90 days of its formation, outlining:
 - A framework for Quality A food standards
 - A transition timeline and compliance guidelines
 - Recommended funding mechanisms, including tax incentives and grants for small businesses
 - Public transparency measures to ensure consumer awareness
- (c) The Task Force shall establish a national grading and certification system for restaurants, indicating compliance with Quality A food standards.
- (d) A phased transition plan shall be implemented as follows:
 - Phase 1 (0-3 months): Data collection, framework development, and initial regulatory drafts
 - **Phase 2 (3-6 months):** Engagement with food suppliers, restaurants, and the public to ensure smooth transition pathways.
 - **Phase 3 (6-9 months):** Pilot program rollout, consumer awareness campaigns, and initial enforcement measures.
 - **Phase 4 (9-12 months):** Full compliance enforcement, finalization of restaurant grading systems, and implementation of penalties for non-compliance.

Section 4: Compliance and Enforcement

- (a) All fast food and restaurant establishments must publicly disclose food ingredient sources and comply with the transition to chemical-free, Quality A food by the one-year deadline.
- (b) Non-compliant establishments will face:
 - Progressive fines for continued violations
 - Possible suspension of operating licenses for repeated non-compliance
 - Public transparency measures, including mandatory disclosure of non-compliance ratings
- (c) Randomized food inspections and laboratory testing shall be conducted to ensure compliance.

Section 5: Funding and Economic Support

- (a) To prevent undue financial burdens on businesses, the federal government shall:
 - Provide **tax credits and financial incentives** for restaurants transitioning to chemical-free food.
 - Establish a **grant fund** to support small businesses in compliance efforts.
 - Ensure **federal procurement contracts** prioritize organic and sustainable farming practices to increase supply chain availability.
- (b) The Department of Agriculture and Department of Commerce shall collaborate with farmers and food distributors to ensure increased production of chemical-free, organic ingredients.

Section 6: Public Engagement and Transparency

- (a) The Task Force shall create a **public reporting system**, including a mobile application and website, allowing consumers to:
 - Report concerns about food quality
 - Access restaurant compliance ratings
 - Receive updates on the implementation of Quality A food standards
- (b) Nationwide town halls shall be conducted to engage with the public and industry stakeholders on the benefits of this transition.

Section 7: Final Provisions

- (a) This Executive Order shall take effect immediately upon signing.
- (b) The CQS Task Force shall submit quarterly progress reports to the President, Congress, and the public, with the final implementation report due one year from the date of enactment.
- (c) The directives within this order shall be enforced in accordance with applicable law and subject to the availability of appropriations.
- (d) If any provision of this Executive Order is found to be invalid, the remainder of the Order shall remain in full force and effect.
