### The United States Constitution

Article II, Section 1 of the U.S. Constitution imposes only three eligibility requirements on persons serving as president, based on the officeholder's age, time of residency in the U.S., and citizenship status:

### U.S. Constitution – Presidential Candidate Eligibility

"No person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President; neither shall any person be eligible to that Office who shall not have attained to the Age of thirty-five Years, and been fourteen Years a Resident within the United States."

## **Draft Executive Order: Ensuring Corporate Accountability to Constitutional Principles**

**By the Authority Vested in Me as President by the Constitution and the Laws of the United States of America, It Is Hereby Ordered as Follows:**

### Preamble

In the enduring pursuit of liberty and justice for all, the Constitution of the United States stands as a beacon of hope, ensuring that the fundamental rights of individuals are protected against encroachment by the government. However, as our society evolves, so too do the dynamics of power. Corporations, wielding unprecedented influence, often operate in ways that profoundly impact the public sphere and our democratic principles. When corporations act as instruments of government agencies or as gatekeepers of essential services, their actions must align with the same constitutional values that safeguard our freedoms.

This Executive Order is a declaration of our collective resolve to close the gaps that allow the erosion of constitutional protections by private entities acting in concert with or on behalf of government interests. It affirms our unwavering commitment to ensuring that the rights enshrined in the Constitution extend into all facets of modern life, where public and private power intersect. With this measure, we aim to establish a foundation of accountability, transparency, and respect for the principles that define our nation.

### Section 1. Purpose

The Constitution guarantees fundamental rights to the people, including freedom of speech, privacy, and protection from discrimination. While these protections constrain government actions, they often do not apply to corporations that operate in the public sphere. This gap has

allowed corporations to act in ways that undermine these rights, sometimes at the behest of governmental agencies seeking to bypass constitutional constraints.

This Executive Order seeks to establish a framework where corporations that operate in partnership with or at the direction of government agencies must adhere to the same constitutional principles that bind the government. It also establishes mechanisms for public oversight and participation to ensure transparency and accountability.

## Section 2. Policy

It is the policy of the United States to ensure that:

- (a) All corporations engaged in activities that affect constitutional rights, directly or indirectly, must operate in a manner that respects and upholds those rights.
- (b) Government agencies shall not use corporations as intermediaries to circumvent constitutional protections, including but not limited to free speech, privacy, and equal protection under the law.
- (c) The public shall have mechanisms to hold corporations accountable for actions that infringe upon constitutional principles.

---

## Section 3. Standards for Corporate Conduct

(a) **Constitutional Compliance:** Corporations operating in partnership with government agencies or providing public-facing services that significantly affect rights shall:

- Refrain from engaging in censorship that violates the spirit of the First Amendment.
- Protect consumer data and privacy in line with Fourth Amendment principles.
- Ensure non-discriminatory practices consistent with the Equal Protection Clause of the Fourteenth Amendment.

(b) **Transparency Requirements:** Corporations must disclose:

- Any agreements or contracts with government agencies that may impact constitutional rights.

### Section 4. Oversight and Accountability

(a) **Independent Oversight Board:** A nonpartisan, public oversight board shall be established to:

- Monitor corporate compliance with this Executive Order.
- Investigate claims of constitutional rights violations by corporations.
- Issue public reports on findings and recommendations.

(b) **Public Reporting Mechanisms:**

- An accessible platform shall be created for citizens to report violations of this Executive Order by corporations.
- Reports will be reviewed and addressed promptly by the oversight board.

(c) **Whistleblower Protections:** Employees of corporations who report violations shall be protected from retaliation under federal law.

---

### Section 5. Public Participation

(a) **Draft Finalization:** This Executive Order is subject to public consultation and amendment. Citizens are invited to submit suggestions and proposed changes by emailing [public@vincentcordova.com](mailto:public@vincentcordova.com).

(b) **Submission Deadline:** Feedback must be submitted within 60 days of the publication of this draft.

(c) **Inclusion of Public Feedback:** All substantive suggestions will be reviewed, and approved changes will be incorporated into the final Executive Order. A summary of accepted and rejected suggestions will be published.

### Section 6. Enforcement

- (a) Corporations found to be in violation of this Executive Order will face penalties, including fines, revocation of government contracts, and legal action, as applicable.
  - (b) Government agencies found to be circumventing constitutional protections through corporate partnerships will be subject to disciplinary actions and further review.
- 

### Section 7. General Provisions

- (a) This Executive Order shall not be construed to impair or otherwise affect the rights and responsibilities of private individuals or entities not engaged in activities covered under this order.
  - (b) Nothing in this order shall be interpreted as limiting the lawful authority of any government agency to enforce existing laws.
  - (c) This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
