The United States Constitution

Article II, Section 1 of the U.S. Constitution imposes only three eligibility requirements on persons serving as president, based on the officeholder's age, time of residency in the U.S., and citizenship status:

U.S. Constitution - Presidential Candidate Eligibility

"No person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President; neither shall any person be eligible to that Office who shall not have attained to the Age of thirty-five Years, and been fourteen Years a Resident within the United States."

Introduction: The Collapse Has Begun — But a Coup is Not the Answer

The United States of America faces a quiet collapse. Our institutions—once designed to serve, protect, and elevate the people—have become bloated, privatized, corrupted, or obsolete. Yet the solution is not to destroy them violently or to seize totalitarian control. The solution is to outgrow them, legally and ethically, by building a new system in parallel.

This white paper proposes a constitutional, peaceful, and people-led strategy for renewal: **The Parallel Renewal Doctrine**.

1. Foundational Premise

"We will not dismantle the old through war — we will walk into the new through peace, participation, and purpose."

The doctrine rests on four core beliefs:

- Systems that no longer serve the people must be replaced, not reformed.
- The Constitution is not inherently the problem but those who interpret and control it without public accountability are. A people-first constitutional reform is necessary to restore balance.
- The federal government can create ethical, transparent, opt-in systems.
- We can build the new without permission but with the full awareness of the public.

2. Legal Tools of Transition

A. Executive Orders

Use EO authority to:

- Establish nonprofit national alternatives (e.g. Public Health Corps, National Housing Guarantee)
- End federal contracts with extractive corporations (private equity-run prisons, healthcare providers, etc.)

B. Federal Pilot Programs

- Launch parallel cities, counties, or programs where new models are tested with full transparency
- Allow public choice between legacy systems and new people-powered systems

C. Constitutional Budget Reallocations

• Shift funding toward ethical institutions not driven by profit (e.g. nonprofit banking, nonprofit insurance, national co-ops)

D. Direct Public Input & Tech

- Create a national app for immediate public voting and policy suggestions
- Invite people to choose between old and new services at no penalty

3. Guiding Ethics

• Nonviolence: No removal of rights or force-based imposition

5. Role of the People

- Citizens will opt into systems through open registration, public vote, or community referenda
- Schools and communities will be invited to help co-create the curriculum, values, and structure of the new systems
- People will be paid to participate in rebuilding through National Transition Corps employment

- **Legally Sound**: Fully within presidential powers when rooted in spending, EOs, and emergency ethics
- Constitutionally Aligned: Upholds liberty, property, equal protection, and due process, while committing to needed reforms to limit centralized misuse
- Peacefully Scalable: Offers an exit from collapse without violence or economic devastation
