

TARRANT RANCH RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND IMDEMNITY AGREEMENT

Please carefully review this agreement before affixing your signature. Your signature confirms your understanding and agreement to its terms. By signing this agreement, both you and/or your child are relinquishing certain legal rights, including the right to sue or seek compensation for injury, death, or property damage, regardless of the cause, including negligence on the part of Tarrant Ranch, its owner, Tarrant Enterprises, employees, agents, or any associates conducting business with Tarrant Ranch (collectively referred to as Tarrant Ranch).

On behalf of myself and my heirs, I hereby:

Agree to release and forever discharge Tarrant Ranch from any and all claims and demands of any kind, nature, or character that I may have now or in the future, arising from any damages, losses, injuries, or death that may be suffered or sustained by me in connection with any activities related to Tarrant Ranch, both on and off its premises. I waive and release all such claims and covenant not to sue. I understand and fully assume all risks and hazards associated with horse riding and related activities, as well as transportation to and from these activities.

I, the undersigned, acknowledge that I have willingly participated in horseback riding activities with Tarrant Ranch.

I understand that horseback riding entails inherent risks of injury, which are an integral part of the activity. I accept full responsibility for these risks, including unpredictable actions of horses or mules such as bucking, stumbling, falling, rearing, biting, kicking, running, making unpredictable movements, spooking, jumping obstacles, stepping on individuals' feet, pushing or shoving people, as well as the potential for saddles or bridles to loosen or break. These risks may result in falls, loss of control, collisions, and encountering obstacles, whether they are obvious or not, leading to serious injury or death. Additionally, I acknowledge that animals, regardless of their training or past behavior, may at times act or react unexpectedly or unpredictably, and I assume these risks as well.

I understand that the terrain may vary, posing risks of injury or damages. I acknowledge that it is my responsibility to manage these hazards, including breaks, vegetation growth, debris, rocks, cliffs, and other potentially hazardous surface or subsurface conditions and obstacles, whether they are easily noticeable or not, whether they are man-made or natural. I am aware that animals are unpredictable, and the inherent risk of injury exists during horseback riding activities. Therefore, I willingly assume all risks of injury or death arising from horseback riding, regardless of the cause.

I acknowledge being informed about the existence of dangerous conditions, risks, and hazards, which may expose both me and my property to potential harm while present and engaging in activities on the premises of Tarrant Ranch. These include, but are not limited to:

- presence of poisonous snakes, insects, ants, and spiders;
- blinds and tree stands, regardless of their origin;
- erosion and general condition of the land, both on and off roadways or pathways, as well as ponds creating rough, hazardous, and dangerous conditions for driving, walking, and horseback riding;
- Presence of wild and domestic animals that may carry diseases and/or pose potential dangers;
- deep water, river currents, and associated conditions;
- individuals with firearms, both on or off the premises, and dangers related to vehicle use

I acknowledge the danger of drowning and recognize that, if available, it is advisable to use a life preserver flotation device near the ponds and lakes on the premises. However, I retain the right to decide whether or not to wear a life preserver. Regardless of my decision, I waive any claims and direct my heirs not to seek damages from Tarrant Ranch in the event of accidental injury or death by drowning on the premises.

I have carefully read the first page of this agreement and fully understand the contents. I am aware that I am releasing certain legal rights that I otherwise may have, and I enter into this contract in behalf of myself and/ or my family of my own free will. THIS IS A RELEASE OF LIABILITY. DO NOT SIGN THIS RELEASE IF YOU DO NOT UNDERSTAND OR DO NOT AGREE WITH ITS TERMS.
