Statement on Population Stabilization by World Leaders

Mankind has many challenges: to obtain a lasting peace between nations; to preserve the quality of the environment; to conserve natural resources at a sustainable level; to advance the economic and social progress of the less developed nations; and to stabilize population growth.

At present there are 76 million more births than deaths on our planet each year. If present rates continue, by the year 2000, there will be 100 million more births than deaths. A billion people have been added in the last 13 years and the next billion will be added in 12 years.

Degradation of the world's environment, income inequality, and the potential for conflict exist today because of over-consumption and over-population. If this unprecedented population growth continues, future generations of children will not have adequate food, housing, medical care, education, earth resources, and employment opportunities.

We believe that the time has come now to recognize the world-wide necessity to stop population growth within the near future and for each country to adopt the necessary policies and programs to do so, consistent with its own culture and aspirations.

To enhance the integrity of the individual and the quality of life for all, we believe that all nations should participate in setting goals and programs for population stabilization. Measures for this purpose should be voluntary and should maintain individual human rights and beliefs.

We urge national leaders to take an active personal role in promoting effective policies and programs. Attention should be given to setting realistic goals and timetables; encouraging active participation of communities in designing and implementing their own programs; and developing appropriate economic and social policies.

We call upon donor nations and institutions to be more generous in their support of population programs in those developing nations requesting such assistance.

Recognizing that early population stabilization is in the interest of all nations, we earnestly hope that leaders around the world will share our views and join with us in this great undertaking for the well-being and happiness of people everywhere.

Déclaration de Dirigeants Mondiaux sur la Stabilisation de la Population

L'homme doit relever de nombreux défis: instaurer une paix durable entre les nations, préserver la qualité de l'environnement, conserver les ressources naturelles pour qu'elles ne s'épuisent pas au point de descendre au-dessous d'un seuil critique, accélérer le progrès économique et social des pays en développement, et stabiliser la croissance démographique.

Actuellement, l'excédent annuel mondial des naissances sur les décès est de 76 millions d'individus. Si le taux annuel des naissances se maintient à son niveau actuel, d'ici l'an 2000 le nombre des naissances dépassera de 100 millions le nombre des décès. La population mondiale a augmenté d'un milliard au cours des 13 dernières années et augmentera encore d'un milliard au cours des douze prochaines années.

La dégradation de l'environnement, l'inégalité des revenus et les risques de conflit sont le résultat de la surconsommation et de la surpopulation. Si la croissance démographique sans précédent à laquelle nous assistons se poursuit au même rythme, des générations entières d'êtres humains se trouveront dépourvues de nourriture, de logements, de soins médicaux, d'éducation, de ressources naturelles et de possibilités d'emploi.

Nous sommes convaincus qu'il est temps maintenant de reconnaître qu'il faut absolument arrêter la croissance démographique dans un proche avenir et que chaque pays doit adopter les politiques et les programmes nécessaires à cette fin, conformément à ses valeurs culturelles et à ses aspirations.

Pour renforcer l'intégrité de la personne humaine et améliorer la qualité de la vie pour tous, nous sommes persuadés que toutes les nations devraient participer à la détermination d'objectifs et de programmes pour stabiliser la population mondiale. Les mesures prises à cette fin doivent respecter la liberté individuelle, les droits de l'homme et les convictions personnelles.

Nous exhortons les dirigeants nationaux à prendre activement part, à titre personnel, à la promotion de politiques et de programmes efficaces. Il faut s'efforcer de se fixer des objectifs et des délais réalistes, d'encourager la participation active des collectivités à l'élaboration et à l'exécution de leurs propres programmes, et à établir des politiques économiques et sociales appropriées.

Nous prions les pays et institutions donateurs d'appuyer plus généreusement les programmes de population dans les pays en développement qui demandent une assistance.

Reconnaissant qu'une stabilisation aussi rapide que possible de la population est dans l'intérêt de toutes les nations, nous espérons fermement que les dirigeants du monde entier partageront notre préoccupation et se joindront à l'œuvre que nous entreprenons pour le bien-être et le bonheur de tous.

Declaración de los Dirigentes del Mundo Sobre la Estabilización de la Población

La humanidad se enfrenta con muchos desafíos: obtener una paz duradera entre las naciones; preservar la calidad del medio ambiente; conservar los recursos naturales en un nivel de sustento; promover el progreso económico y social de las naciones menos desarrolladas; y estabilizar el crecimiento de la población.

Actualmente, en nuestro planeta los nacimientos superan las muertes, en 76 millones cada año. Si se mantienen las tasas de natalidad actuales, para el año 2000 esa cifra habrá aumentado a 100 millones. Se han sumado 1.000 millones de personas a la población mundial en los últimos 13 años y se sumarán otros 1.000 millones en los próximos 12 años.

La degradación del medio ambiente mundial, la desigualdad en los ingresos y las posibilidades de conflicto que se observan actualmente se deben al consumo excesivo y al exceso de población. Si persiste este crecimiento demográfico sin precedentes, las futuras generaciones de niños no tendrán alimentos, vivienda, atención médica, educación, recursos naturales y oportunidades de empleo en cantidad suficiente.

Creemos que ahora ha llegado el momento de reconocer a nivel mundial la necesidad de que se frene el crecimiento de la población en un futuro próximo y de que cada país adopte las políticas y los programas necesarios para ello, de conformidad con su propia cultura y sus aspiraciones.

A fin de realizar la integridad del individuo y la calidad de la vida de todos, creemos que todas las naciones deben participar en el establecimiento de metas y programas para la estabilización de la población.

Exhortamos a los dirigentes nacionales a que desempeñen personalmente un papel activo en la promoción de las políticas y los programas. Se debe tratar de fijar metas y plazos realistas; alentar la participación activa de las comunidades en la formulación y ejecución de sus propios programas; y elaborar políticas económicas y sociales apropiadas en materia de incentivos y desincentivos.

Hacemos un llamamiento a las naciones e instituciones donantes para que sean más generosas en el apoyo que prestan a los programas de población de los países en desarrollo que solicitan asistencia en esa esfera.

En vista de que percibimos que la pronta estabilización de la población beneficia a todas las naciones, esperamos sinceramente que los dirigentes del mundo compartirán nuestras ideas y se sumarán a nosotros en esta magna empresa en favor del bienestar y la felicidad de todos los habitantes de nuestro planeta.
