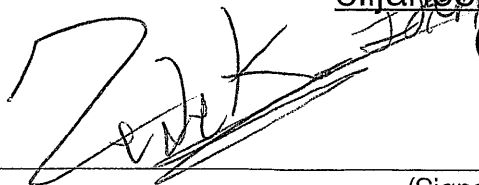

Final Notice and Additional Information

Comes now ELIJAH SHANE CODNER the Defendant, by and through Jah Rastafari Malchizedek who is C.E.O. of the parent company RANDOLPH CODNER and who is lawfully responsible & legally accountable for all claims made against the Defendant, and who is fully competent to represent or speak as, for, over and in behalf of Defendant whose trust is in God, to notify the Court that Defense was barred from physically entering the public court room (see Exhibits #6) and then denied access from the Zoom hearings (see Exhibit #10). Court houses are considered sacred places to God because they are central to the administration of law and to the demonstration of the power thereof. For it is written: God is Judge (Psalms 50:6).

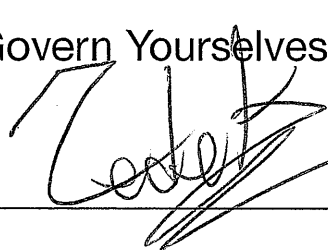
